Advertisement notification dated 15/03/2017 read with corrigendum notice dated 06/04/2018, vide which 233 vacancies of SI/Overseer, ASI/Draughtsman, CT/Pioneer (Mason/Plumber/Electrician /Carpenter/Painter) were notified. **On 03/5/2017** i.e. before written exam held on 30/7/2017 **a corrigendum notice dated 02/5/2017 was issued regarding securing of minimum cut-off marks in each part of the paper to qualify in written exam.** It was uploaded on web sites ie www.crpfindia.com & www.crfp.nic.in on 03/5/2017 and published in Employment News week ending 20-26/5/2017.

3. The matter has now been scrutinized based on corrigendum dated 02/5/2017 and result has been withdrawn keeping in view the mandatory requirement of scoring minimum prescribed marks in each part of the paper.
4. Also some corrections were noticed in answer keys which have been implemented in fresh result.
5. Hence, entire result for the post of SI/Overseer(Civil), ASI/Draughtsman, CT/Pioneer(Mason/Plumber/Electrician/Carpenter/Painter) declared and uploaded on CRPF website (www.crfp.gov.in) on 31/5/2018 is hereby cancelled and declared void.
6. A fresh merit list being drawn after scrutiny of the above said errors and published on CRPF website to invite objections from candidates on correctness of questions and answers if any. The candidates are advised to check the CRPF website and convey their objections if any by prescribed dates.
