2. All the material to be used on works shall bear ISI certification mark unless otherwise the make is specified in the term or special conditions appended with this tender document. In case ISI mark materials of the materials mentioned in the tender documents are not available, as per opinion of the Commandant 06 Bn CRPF Katra, Reasi, (J & K) specifications applicable in this tender or IS code. In such the Commandant 06 Bn CRPF Katra, Reasi, (J & K) shall satisfy himself about the quality of such work and give his approval in writing. Only articles classified as first quality by the manufacturers shall be used unless otherwise specified. All material not having ISI mark shall be tested as per relevant ISI specifications. The Commandant 06 Bn CRPF Katra, Reasi, (J & K) may relax the condition regarding testing if the quantity of the materials required for the work is small. In all cases of use of ISI marked materials proper proof of procurement of materials from authentic manufacturers shall be provided by the contractor to the entire satisfaction of the Commandant 06 Bn CRPF Katra, Reasi, (J & K).
