Note-5 : The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Govt., shall ordinarily not to exceed three years.

Note- 6 : The maximum age-limit for appointment by deputation shall not be exceeding 56 years as on the closing date of the receipt of application.
