



I am directed to refer to DG, CRPF's letter No.U.II.1/2017-18-Prov(Clo)-DA-6 dated 11.04.2018 on the subject mentioned above and to convey the sanction of competent authority for authorization of uniform items for one Mahila Battalion (i.e. 232 Bn) deployed in LWE area at an estimated cost of Rs.33,81,008/- (Rupees Thirty Three Lakh Eighty One Thousand and Eight only) per annum against surrender of uniform items subject to condition that none of the authorized uniform items are in the category of 'Basic Uniform'. 
