### ORDER

In order to extend financial assistance to the personnel injured/disabled in action during operation and duties, it has been decided to provide financial assistance out of Central Welfare Fund to such persons as per following category:

SI.No.	Category	Nature of injury	Financial assistance
01	"A"	Minor injuries for which medical attention is required due to stone pelting/ in law and order duties, injuries due to rescue and relief operations/ in action during operations.	Rs. 4,000/- (to each injured person)
02	"B"	Grievous injuries leading to hospitalization or fracture of bones/ stitches etc. due to stone pelting/ in law and order duties, rescue and relief operation/ in action during operation.	Rs. 25,000/- (to each injured person)
03	"C"	Grievous injuries due to bullet/splinter/blast during operation leading to hospitalization but without causing permanent disability.	Rs. 50,000/- (to each injured person)
04	"D"	Grievous injuries in action during operational duties leading to hospitalization and permanent disability.	Rs. 1,00,000/- (to each injured person) not be adjusted with other payments.

#### PROCEDURE FOR PAYMENT:

2. On the occurrence of any eventuality, the Commandant will prepare a categorywise list of injured personnel with date, time and place of incident. The Medical Officer of the Unit/GC/CH will conduct a medical examination and categorise them as per gravity of injury and forward their recommendation to the Commandant. Thereafter, Commandant will forward the case duly recommended to Sector IG through Range DIG. The Sector IG will further recommend the amount to be sanctioned to the injured personnel to the Welfare Directorate. On receipt of the list of injured personnel, sanction shall be accorded as OUTRIGHT GRANT from Central Welfare Fund by the Competant Authority as per following financial competence:

(i)	DG	Full powers
(ii)	ADG (HQr)	Upto Rs. 2,00,000/-
(iii)	IG (Adm)	Upto Rs. 1,00,000/-
(iv)	DIG (Welfare)	Upto Rs. 50,000/-

- After sanction is accorded, the amount will be remitted to the concerned 3. Sector IsG through ECS. Sector will further remit the amount to the Commandant, who will disburse the same to the individual concenred and obtain his signature for having been received the amount and shall send a copy of list of injured personnel along with the receipt duly signed by the individual to this Directorate.
- 4. The Commandant will open a separate register to maintain proper record.
- This order will come into effect w.e.f. 1<sup>st</sup>March, 2016. 5.
