

ORDER

Govt. of India /Ministry of Home Affairs vide its letter No. II-27012/13/2019-PF.III (i) dated 21/02/2019 & 04/02/2020 has allowed /extension of period of air travel to all non-entitled personnel of CAPFs to travel by air from Jammu to Srinagar and back for the purpose of official duty / transfer / tour and leave (on termination /commencement at base point Jammu) and from Delhi to Srinagar and back on official duty / Transfer / Tour. On receipt of queries from various corners, the issue has been examined with relevant rules and instructions for allowing reimbursement of Air Ticket to those personnel who undertake air journey from Srinagar to their home town and vice-versa, against single/direct air ticket purchased from their own pocket.

2. Under the provisions contained in SR-48 B 4 (a), GoI decision No.13, 21(2) below Rule 12 of Swamy's Compilation of Central Civil Services (LTC) Rules read with aforesaid MHA's letter dated 21/02/2019 & 04/02/2020 and MHA's UO No.II-27012/13/2019-PF-III dated 29/11/2019, non-entitled personnel of CRPF who undertake air journey from Srinagar to their home town and vice-versa are hereby permitted for re-imbusement of air ticket , against single/direct air ticket purchased from their own pocket, in the following manner:-

Travel from – to	Payable amount
If the individual travels from Srinagar to Jammu & vice versa by air	Actual amount of Air Ticket without any cap.
If the individual travels by air from Srinagar to Home town (or any other airport beyond Jammu) or vice versa on single air-ticket on FLP/LTC.	The rate per seat between Jammu – Srinagar or vice versa may be restricted @ Rs.3,454/- (Max.) which is the Air India's Air Courier Service ticket rate per person already been objectively fixed by MHA vide Id No. CF-3447670 /MHA /AW/2019/389 dated 27/05/2019. i) If the complete air fare paid by individual is less than Rs. 3,454/- actual fare be paid debitable under head "DTE". ii) If it is more than Rs. 3,454/- he may be paid : a) Fixed air fare per seat for ACS on Jammu-Srinagar Sector Rs. 3,454/- debitable under head "DTE" and b) Entitled class train fare beyond Jammu or vice versa (subject to total fare paid by an individual) debitable under head "Salaries". iii) The total fare reimbursed in any case shall not be

more than total fare paid by an individual.

3. These non-entitled personnel will be required to produce the air-ticket/boarding pass and a receipt from the concerned airlines showing the fare paid by the concerned individuals, if the ticket does not indicate the airfare, while claiming reimbursement of LTC/FLP in terms of Rule 12 of LTC Rules, as indicated above.

4. While purchasing Air Ticket to undertake air journey from Srinagar to Home Town and vice versa against single/direct air ticket from their own pocket, instructions issued vide this Dte signal of even number dated 22/02/2019 and 19/02/2020 may be strictly adhered to.

5. This issues with the concurrence of FA/Director (Accounts), PAO, CRPF and approval of DG.
