U/C(.)**Time bound**(. ) Job Opening: UN Police Adviser (P-4) in United Nations Interim Force in Lebanon (UNIFIL)( Job Opening No. 2015-UNIFIL-57112-DPKO) (. ) Ref this Dte Selo Message of even no. Dated 13/10/2016 (.) MHA vide ID No. 21023/51/2015-PMA dated 21/03/2017 has conveyed approval of competent authority for deployment of Shri Nisheet Kumar, Comdt (IRLA-4227) of 154 Bn who has been selected for the post of Police Adviser (P-4) in the United Nations Interim Force in Lebanon (UNIFIL) for a one-year fixed term (extendable) of appointment on secondment (.) Further, the officer has to carry his original official passport, relieving order and certificate/ confirmation regarding non- involvement in any disciplinary and human rights issues (.) As per earlier practice and directions of MHA, officer should bring following:-

- a) **CASH** : Police officer must bring sufficient cash (USD) to sustain one(1) week during the induction in, Lebanon( UNIFIL) ( USD \$ 100 per day).
- b) Vaccination Certificate- Yellow Fever/Cholera vaccination is mandatory and proof of immunization must be produced at entry for all travelers.
- c) Malaria: Malaria Prophylaxis is required as per UN guidelines.
- d) In-Mission test in Language & Driving- He must have at least two year recent driving experience and must be in possession of valid National Or International Civilian Driving Licenses. He must have presented his valid National Driving License upon arrival in the Mission area. The license should be valid during his service in the Mission. He is subjected to in-mission assessment in driving skills. If fail, he will be repatriated at his own expense.
- e) Medical examination: pre-deployment dedication examination is required to be complete in accordance with the guidelines for the UN Police Officers on assignment with Peace Keeping Missions.
- f) Original receipt certifying depositing of personal passport with the issuing authority in case of any passport held earlier.
- g) To hand over the NOC/ relieving order/ disciplinary/vigilance clearance issued by department at the time of reporting at United Nations Interim Force in Lebanon (UNIFIL)HQr.

h) Officer has to compulsorily get the uniform and bear the cost of uniform from his personal saving. He is entitled to carry 100 Kg total baggage, including hand/cabin baggage.

(. ) An undertaking is to be obtained from the above officer prior to his UNIFIL deployment that, he will not overstay in Mission (. ) It is further mentioned that the officer is deemed to have been relieved on the date of expiry of the UN deployment/deputation period unless the competent authority has with requisite approvals, extended the period of deputation/UN deployment, in writing, prior to its date of expiry (. ) In the event of the officer overstaying for any reason whatsoever, he is liable for disciplinary action and other adverse Civil. Service consequences which would include the period of overstay not being counted for service for the purpose of pension and that any increment due during the period of overstay being deferred with cumulative effect, till the date on which the officer rejoins in CRPF (. ) Proceedings for deemed resignation from service would also be initiated (. ) Terms and conditions, if any, other than the above mentioned will be communicated on receipt from MHA (. ) This may be brought to the notice of the officer (. ) **PARA (. )** Request relieve the above officers **with immediate effect** with direction to report to the United Nations Interim Force in Lebanon (UNIFIL) HQr alongwith above documents (. ) Date of relieve may be intimated to all concerned by R/Sig (. ) Relieving order along with CTC may also be forwarded to all concerned (. ) MMU ///--
