(.) The terms and conditions of appointment on deputation will be governed as per provision contained in DOP&T OM No. 6/8/2009-Estt(Pay-II) dated 17/06/2010 as amended from time to time (.) The officers will be entitled to draw Special Allowances @ 20% of Basic Pay (.) However, no Deputation (Duty) Allowance will be paid (.) The officers to be relieved for duties at the earliest with direction to report to the Joint Secretary(Personnel) at NTRO Hqrs, Block-III,Old JNU Campus, New Delhi to assume charge on their appointment in NTRO (.) After reporting at NTRO Hqr, New Delhi and completion of joining formalities, their actual place of posting in NTRO would be decided depending upon organizational requirement (.) Their transfer TA would be regulated as per entitlement/admissibility from place of posting in present organization to such actual place of posting in NTRO (.) While relieving the officers, it may be ensured that the officers are clear from disciplinary and vigilance angle (.) MHA has also accorded approval for relieving of above officers on deputation to NTRO (.)
