

## **Ops achievements from 27/04/20 to 31/5/20**

### **1. CHHATTISGARH**

- i. On 11-05-20, CRPF troops along with state police during Special Joint Ops at Uripal Forest Area, U/PS-Mirtur, Distt- Bijapur, an encounter took place between troops and Maoists in which martyred F/No. 115176664 Ct/GD Munna Yadav (32 Yrs, Married, r/o- Sahebganj, JKD) of 170 Bn (attached with SAT Range Bijapur) troops fired following Ammn:-
  1. 7.62 mm - 200 rds
  2. 5.56 mm - 05 rds
  3. UBGL - 11 rds
  4. 51 mm Mortar HE Bomb

- ii. On 30-05-20, CRPF troops along with state police during SADO duty at Vikrampalli, U/PS-Jagargunda, Distt-Sukma apprehended a CPI(Maoist) LGS commander of Jagargunda namely Sunnam Sanna (rewardee of 5 lakh).

### **2. JHARKHAND**

### **3. TELANGANA**

- i. On 30-05-20, CRPF troops along with state police during area domination duty at Chintagupa forest area, U/PS-Cherla, Distt-Khammam apprehended 01 RPC member and 02 courier of CPI(Maoist) along with 25 gelatine sticks.

## Jammu & Kashmir

1. On 27/04/20, an encounter between the terrorists and the joint troops of CRPF, SOG and RR took place in the area of Sadiwara/Lower Munda, PS Qazigund, DistKulgam. During post encounter search, troops recovered 03 dead bodies of killed terrorists with weapons.
2. On 28-29/04/20, an encounter between the terrorists and the joint troops of CRPF, SOG and RR took place in the area of Melhura, PS Zainapora, DistShopian. During post encounter search, troops recovered 03 dead bodies of killed terrorists with weapons.
3. On 02/05/20, an encounter between the terrorists and the joint troops of CRPF, SOG and RR took place in the area of DangerporaMohalla, PS & DistPulwama. During post encounter search, troops recovered 02 dead bodies of killed terrorists with weapons.
4. On 01-03/05/20, an encounter between the terrorists and the joint troops of CRPF, SOG and RR took place in the area of WadderBala/ Chanjimullah, PS Handwara, DistKupwara. During post encounter search, troops recovered 02 dead bodies of killed terrorists with weapons. In this encounter 04 RR personnel and JKP personnel attained Martyrdom.
5. On 05-06/05/20, an encounter between the terrorists and the joint troops of CRPF, SOG and RR took place in the area of Beighporaama, PS Awantipora, DistPulwama. During post encounter search, troops recovered 02 dead bodies of killed terrorists with weapons
6. On 06/05/20, an encounter between the terrorists and the joint troops of CRPF, SOG and RR took place in the area of Shar, PS Khrew, DistPulwama. During post encounter search, troops recovered 02 dead bodies of killed terrorists with weapons.
7. On 16/05/20, the troops of CRPF, RR and JKP, carried out CASO duty at Chakora PS Litter, DistPulwama During search, troops recovered SLR- 01 with 01 mag and 157 rounds, Pistol 02 with 01 mag, AK 47 mag- 06, AK 47 rounds- 1050, Pika rounds- 235, 9 mm rounds- 317, Sniper amn- 835 , IED material (including explosives, batteries and detonators and Misc items).
8. On 17/05/20, an encounter between the terrorists and the joint troops of CRPF, SOG and RR took place in the area of Khotra, PS & DistDoda. During post encounter search, troops recovered 01 dead body with 01 AK 47 and 02 magazine.
9. On 25 May 20, the troops of CRPF, RR and JKP, carried out CASO duty leading to encounter at Hanjipora, PS Manzgam, DistKulgam. During post encounter search troops recovered 02 dead bodies of militants along with Pistol- 02 Nos.
10. On 30 May 20, the troops of CRPF, RR and JKP, carried out CASO duty leading to encounter at Wanpora, PS Wanpoh, DistKulgam. During post encounter search troops recovered 02 dead bodies of militants along with Chinese Pistol- 02 Nos, Chinese Grenade- 01 No, Chilli Grenade- 03 Nos.
