a)	To ensure, verify the correctness of details in the concerned application form and uploaded documents submitted by the student/applicant as per PMSS guidelines.
b)	To ensure to monitor overall pendency of the concerned applications under Fresh/Renewal category for the scheme at Institute Level.
c)	The Force Nodal officer shall ensure that the concerned applications are scrutinized/verified well-in-time by the Institute.
