G.S.R.----(E).— In exercise of the powers conferred by section 18 of the Central Reserve Police Force Act, 1949 (66 of 1949), the Central Government hereby makes the following rules regulating the method of recruitment to the post of Assistant Commandant (Matron), Para-Medical Cadre, in the Central Reserve Police Force, Ministry of Home Affairs, namely:-

- 1. **Short title and commencement.-** (1) These rules may be called the Ministry of Home Affairs, Central Reserve Police Force, Assistant Commandant (Matron), Group 'A' post, Recruitment Rules, 2025.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Definitions.-** (1) In these rules, unless the context otherwise requires,-
 - (a) "Director General" means the Director General, Central Reserve Police Force;
 - (b) "SHAPE-I" refers to the medical category as specified under the Central Reserve Police Force Standing Order No. 04 of 2008 dated the 15th December, 2008, and subsequent amendments issued by the Directorate General, Central Reserve Police Force from time to time.

- (2) The words and expressions used herein and not defined shall have the same meanings assigned to them in the Central Reserve Police Force Act, 1949, and the Central Reserve Police Force Rules, 1955.
- 3. **Application.-** These rules shall apply to the posts specified in column (1) of the schedule annexed to these rules.
- 4. **Number of post, classification and level in pay matrix.-** The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 5. **Method of recruitment, age-limit, qualifications, etc.-** The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- 6. **Disqualification.** No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 7. **Maintenance.-** Every post remained unfilled and every vacancy that may arise thereafter shall be filled in accordance with the provisions as specified in the said Schedule and the procedure as may be prescribed by the Central Government from time to time.
- 8. **Seniority.-** Seniority shall be regulated in accordance with the Central Reserve Police Force Rules, 1955, and general instructions issued by the Central Government from time to time.
- 9. **Ineligibility of non-citizens of India.-** No person, who is not a citizen of India shall, except with the prior permission of the Central Government in writing, be appointed under these rules:

Provided that nothing contained in this rule shall debar the appointment or employment of a subject of Nepal or Bhutan in the Force.

10. **Superannuation.-** (1) Every person appointed under these rules shall retire from service on the afternoon of the last day of the month in which he or she attains the age of sixty years or as prescribed by the Central Government from time to time:

Provided that the person whose date of birth is on the first day of a month shall retire from service on the afternoon of the last day of the preceding month on attaining the age of superannuation.

- (2) No person shall be granted extension in service beyond the prescribed age of retirement on superannuation.
- 11. **Liability of service.-** Any person, appointed to the said post under these rules shall be liable to serve anywhere in India or abroad.
- 12. **Interpretation.-** If any question relating to the interpretation of these rules arises, it shall be decided by the Central Government.

- 13. **Power to relax.-** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.
- 14. **Saving.-** Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Exservicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Promotion:

- (a) Promotion from amongst the Subedar Major (Sister-in-Charge) of the Central Reserve Police Force in level 8 in the pay matrix (Rs. 47600- 151100) with four years regular service in the grade and having successfully completed pre-promotional course as prescribed; and
- (b) the candidates shall be in medical category SHAPE-1.

Note.- Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors shall also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying eligibility service or two years, whichever is less, successfully and have completed probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.
