

MEMORANDUM OF UNDERSTANDING (MoU)
BETWEEN
CENTRAL RESERVE POLICE FORCE, (REPRESENTED BY
THE PRESIDENT, RCWA, CRPF, LUCKNOW) AND
DHYEYA FOUNDATION LUCKNOW UTTAR PRADESH

1. **Parties.** The parties to this Memorandum of Understanding (MoU) are the Group Centre, CRPF represented by the PRESIDENT, RCWA (hereinafter called "CRPF") having its address at GROUP CENTRE, CRPF, BIJNOR, LUCKNOW, UTTAR PRADESH, PIN 22602 and DHYEYA FOUNDATION, represented by the Director (hereinafter called "DHYEYA FOUNDATION") having its address at HOUSE NO-40, PINK CITY, SECTOR 6, JANKIPURAM EXT. LUCKNOW, UTTAR PRADESH-226021. These entities are collectively referred to as the "Parties" and individually as a "Party" as the case may be.

2. **Objectives.** This Memorandum of Understanding (MoU) is aimed to: -

- (a) Provide a formal basis for initiating interaction between CRPF and Dhyeya Foundation.
- (b) Welfare of wards of Dependent of Martyrs/deceased/Retired & voluntarily Retired and Serving Gazetted Officers/Subordinate Officers & Other Ranks of CRPF.

3. **Plan.** It is envisaged that CRPF and Dhyeya Foundation shall collaborate through following: -

- (a) Preparation for Competitive Exams vis-à-vis Civil Services (IAS, State PCS, Judicial Service Examinations, APO, Law Entrance Exams & Test series of interested dependents of Martyrs/deceased/Retired & voluntarily Retired and Serving Gazetted Officers/Subordinate Officers & Other Ranks of CRPF on discount basis.

4. **Agreements for Collaboration.** :- This MoU shall serve as an aegis for carrying out interaction in the areas of mutual interest with CRPF and offer preparation for competitive Exams for wards of Martyrs/deceased/Retired & voluntarily Retired and Serving Gazetted Officers/Subordinate Officers & Other Ranks of CRPF on fee concession basis. The signing of this document does not entail any financial or legal obligations on either party. Essentially, this MoU is a frame work within which subsequent agreements, replete with financial implications and relevant details can be signed, for carrying out specific research and undertaking focused studies for resolving a particular technical issue or alleviating a technical

problem. The terms and conditions of any such MoU / Agreements / Addendum etc. subsequent to this MoU shall be exchanged and discussed in detail by the representatives of both the parties prior to signing or executing.

5. **Administration.** This will be in two tiers as mentioned below:-

- (a) **Joint Managers.** Each party will be represented by one person to act as the Joint Manager of this MoU. **PRESIDENT, RCWA, GROUP CENTRE, CRPF, BIJNOR, LUCKNOW** will act as Joint Manager for CRPF while Professor-in-Charge (External Relations) will act as the Joint Manager for Dhyeya Foundation.
- (b) **Managers.** Each Joint Manager may nominate appropriate personnel to manage the details of activities related to execution of individual programmes signed under this master agreement.

Conduct of various program :-

06. **Salient Features of Competitive Coaching :-.**

- (a) Dhyeya Foundation will offer wards to prepare for various competitive examinations vis-à-vis Civil Services (IAS, State PCS, Judicial Service Examinations, APO, Law Entrance Exams & Test series of interested dependents of Martyrs/deceased/Retired & voluntarily Retired and Serving Gazetted Officers/Subordinate Officers & Other Ranks of CRPF on fee concession basis.
- (b) Interested wards of Martyrs/deceased/Retired & voluntarily Retired and Serving Gazetted Officers/Subordinate Officers & Other Ranks of CRPF can make their career in the respective field of civil services.
- (c) The aid being provided by the institution to the wards of Martyrs/deceased/Retired & voluntarily Retired and Serving Gazetted Officers/Subordinate Officers & Other Ranks of CRPF exclusively available on tuition fees only and the standard charges for study material will apply as it is. The details of concession on fees is as under :-

(d) Each candidate appearing for the exam in the interested course will have to score a minimum 35% of marks in the exam conducted to be eligible for the scholarship criteria they fall into.

(e) The candidates can get the coaching classes through online and offline modes. The offline coaching Centres of Dhyeya Foundation are being running in the following cities :-

- (i) Lucknow (ii) Prayagraj (iii) Delhi (iv) Banaras
(v) Gorakhpur (vi) Kanpur (vii) Greater Noida.

14. **Termination.** Either party may, on giving 'six months' notice in writing propose to foreclose this MoU or renegotiate its conditions. In such cases, the team that has commenced project under should be allowed to complete the work adhering to the applicable conditions.
