### **Memorandum of Agreement**

#### PURPOSE FOR MOA:-

Autism spectrum disorder (ASD) is a complex developmental condition that involves persistent challenges in social interaction, speech and nonverbal communication and restricted/repetitive behaviors. The effects of ASD and the severity of symptoms are different in each person. Many wards of CRPF personnel are suffering from Autism Spectrum disorder. Obtaining an accurate diagnosis and its proper treatment is one of the major difficulties faced by parents of children with autism. Since the CRPF personnel are always detached from their family due to their deployment around the country, such autistic children are deprived of adequate parental control and proper treatment.

#### WE THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:-

- 1) Yatnarth Super Specialty Hospitals is a private hospital under a unit of AKS Medical & Research Centre Pvt. Ltd. It has a 450 hospital at HO-1, Sector-1, Greater Noida West and has the expertise, facilities and space required to manage Autism Spectrum Disorder and related Medical issues.
- 2) The Hospital is recognized under State/CGHS as authorized medical attendant/referral hospital for treatment of its beneficiaries and Members of their families subject to the conditions hereinafter mentioned from the date of signing of this agreement by both the parties.
- 3) It will charge the CRPF beneficiary or his/her family members within the celling limits as described.
- 4) It shall in no event charge an amount more than the amount agreed to.
- 5) It shall not discriminate in the provisions of the facility and treatment in any manner whatsoever against the CRPF beneficiary receiving treatment in the hospital as compared to any other patient of equal status and coming for treatment.
- 6) The Hospital shall provide access to the financial and medical records for own assessment and review by the Medical Officer authorized by CRPF.
- 7) Any liability arising due to any default or negligence in providing or performance of the medical services shall be borne exclusively by the hospital who shall alone be responsible for the defect in rendering such services.
- 8) In case of any complaint of overcharging, the CRPF may after factual enquiry, de-recognize the Hospital and decision of CRPF shall be final without any notice and this shall be without any prejudice to any other action to be taken as per the provisions herein contained.
- 9) On production of CRPF identity Card and a valid referral by the CRPF beneficiary the hospital would provide treatment to such parents on heavily subsidized rates.
- 10) This agreement contains the entire terms and conditions between the two parties are nothing outside this Agreement shall be valid and binding. This Agreement can be modified or altered only on written agreement signed by both parties.
- 11) The agreement may terminated by one calendar month's notice in writing and the notice given by the CRPF shall be valid if given and signed either by DG or IG VS Wing Dte. on his behalf can sign the notice of termination.
- 12) The memorandum of Agreement (MOA) sets out the principles for collaborative assessment, planning and service delivery for the Autistic Children by Yatharth Super Specialty Hospital HO-1, Sector-1, Greater Noida West.
- 13) Children with Autism is covered under this MOU with a request for assisting the parents /

Families who have the primary responsibility for upbringing, protection and development of their children. Aside from child protection responsibilities this MoU recognises the voluntary nature of care and support services for children with autism & other disabilities, and the importance of working sensitively with parents to assist them to continue to support their childs.

- 14) TRAINING ASSISTANCE:- Yatharth Super Specialty Hospital will provide free assistance and support with regard to parenting tips, treatment advice, creating consistency in child's environment, advice for in-home behavioral therapy and school bases programme, which can help by making life with an Autistic Child easier.
- 15) DEPLOYMENT OF LEARNING AIDS:- Various learning aids like puzzle, Hard writing Grips, finger puppet, memory games, soft toys, soft mattress, Hard binding books, colouring blocks, colour rings, colourful chart, classic story book, speech therapy mirror, educational toys, part of speech game etc. are some learning aids for the autistic children. Yatharth Super Specialty Hospital will provide guidance/ tips about deployment of these learning aids to help students with autism thrive in the classroom environment.
- 16) With the above background Yatharth Super Specialty Hospital will provide services to the wards of CRPF personnel affected with Autism Spectrum Disorder:

- b. Consultation
- c. Treatment/Investigation in OPD
- d. Admission Charges
- e. On Admission Treatment /

- f. Occupational Therapy/ Physiotherapy

17) All notices and reference hereunder shall be deemed to have been duly served and given to the hospital if delivered to the hospital or their authorized agent or left at consent by registered post to the address stated herein before and to the CRPF if delivered to the IG VS Wing Dte. or sent by registered post or left at his office during office hours on working day.

- 18) The administrative cost of the hospital and all other expenses required by the hospital for purpose of this Agreement shall be borne by the hospital and also the hospital shall pay all expenses incidental to the preparation and stamping of this Agreement.
- 19) Both the parties shall have liberty at any time to terminate this agreement by giving one month notice in writing.
- 20) The agreement shall remain in force for a period of three years or till revocation by any of the parties.
- 21) Two original copies of his agreement are made on Non-judicial stamp papers of Rs. 100/- each one of which will be kept at the Office of the IGP, VS Wing Directorate, CRPF, New Delhi and the other shall be retained in the Office of Yatharth Super Specialty Hospital, HO-1, Sector-1, Greater Noida West.
