MEMORANDUM OF UNDERSTANDING (MoU)
BETWEEN
Central Reserve Police Force (Represented by President CWA)
AND
DAV University, Jalandhar

1. Parties

- a. The parties to this Memorandum of Understanding (MoU) are the CRPF Welfare Association (CWA) represented by its president (hereinafter called "CWA") having its address at Directorate General, CRPF BLOCK NO-1, CGO COMPLEX, LODHI ROAD, NEW DELHI-110003 and DAV University, Jalandhar, having its campus at Jalandhar-Pathankot National Highway, Jalandhar (Punjab) represented by the Vice-Chancellor. These entities are collectively referred to as the "Parties" and individually as a "Party" as the case may be.

2. Objectives

This Memorandum of Understanding (MoU) is aimed to:

- a. Provide a formal basis for initiating interaction between CWA/its regional branches called RCWA and DAV University, Jalandhar.
- b. Welfare of wards of personnel through CWA by offering higher education to their family members. CWA is a non-profit organization run for the serving and retired CRPF families including that of the martyrs and deceased Central Reserve Police Force personnel.

3. Plan

It is envisaged that CWA and DAV University, Jalandhar shall collaborate through the following:

- a. Visits by faculty, students and other staff of DAV University, Jalandhar to establishments/Units of CRPF for the purpose of creating awareness and understanding of the CRPF among the youth of the country.
- b. Any other mode of interaction or communication related to spreading awareness of both institutions in areas and communities of mutual interest.
- c. Conduct of Technical education, including boarding where required and offered, as well as other educational services for wards/families of CRPF personnel.

4. Agreements for Collaboration

This MoU shall serve as an aegis for carrying out interaction in the areas of mutual interest with CWA and offer higher education for wards/families of CRPF personnel (through CWA). The signing of this document does not entail any financial or legal obligation on either party. Essentially, this MoU is a framework within which activities shall be planned with the mutual consent of both parties, and through which wards of CRPF families shall be nominated and admitted to DAV University, Jalandhar. This MoU also provides the framework within which any subsequent agreements, replete with financial implications and relevant details can be signed if deemed necessary by the parties.

5. Administration

This will be in two tiers as mentioned below:

- a. Joint Managers
Each party will be represented by one person to act as the Joint Manager of this MoU. Secretary CWA will act as Joint Manager for CWA while Vice-Chancellor will act as the Joint Manager for DAV University, Jalandhar.

b. Managers

Each Joint Manager may nominate appropriate personnel to manage the details of activities related to execution of individual programmes signed under this master agreement.

Conduct of Higher Education Programme

6. **Salient Features**

The Educational Programmes have the following salient features:

- a. Families of CRPF Personnel through CWA will be offered admission in DAV University, Jalandhar based on the age and eligibility of the wards as per the eligibility criteria of DAV University, Jalandhar.
- b. It will be open to wards/families of serving, retired, and other CRPF personnel.
- c. Admission to the University, only wards of martyr / serviceman / ex-serviceman families of CRPF (represented by CWA) will be offered **100 Free Seats in the various programmes as per Annexure-I wherein we will be giving special scholarship of 100% Annual Tuition Fee and in Hostel Charges, 50% in rental part of 4-seater non-AC room every year. Beyond the commitment of 100 free seats to the wards of the martyr / serviceman / ex-serviceman families of CRPF, DAV University will also offer special scholarship of 40% of the Annual Tuition Fee to the wards of CRPF families enrolled through CWA every year.** The admission of any wards to the University shall always be subject to an interview with the academic staff, fulfilling the eligibility criteria and all other regulations of DAV University, Jalandhar.

7. **Financial Implications on Wards Enrolled in the University**

a. Financial Provisions

The wards of CRPF families enrolled in the 100 free seats shall not pay 100% Annual Tuition Fee and 50% of the hostel rental part of 4-seater non-AC room every year. However, there are expenses associated with food and other variable costs, such as electricity and maintenance, which need to be paid separately. Beyond the commitment of 100 free seats to the wards of the martyr / serviceman / ex-serviceman families of CRPF, DAV University will also offer special scholarship of 40% of the Annual Tuition Fee to the wards of CRPF families enrolled through CWA every year.

b. Transport, Cafeteria, Boarding

Wards opting to avail the following facilities shall do so on a payment basis, subject to availability:

- i. Transport to and from the Campus on the University Buses
- ii. Food provided in the cafeterias
- iii. Other auxiliary services offered by the University.

8. **Sharing of Facilities**

Both CRPF and DAV University, Jalandhar shall allow the sharing of facilities as per the following arrangements:

- a. Visits by faculty, students and staff of DAV University, Jalandhar to CRPF through CWA for spreading awareness and understanding of the CRPF and its role in the history and importance to the future of the nation by mutually agreed terms, if feasible.
- b. CRPF through CWA and DAV University, Jalandhar shall make provisions to share their respective facilities on case-to-case basis and mutually agreeable terms in order to promote academic interaction in the areas of cooperation.

9. Confidentiality

- a. Classified / confidential information means information of material, regardless of its form, that in accordance with the laws, regulations or policies of a Party requires protection in the interests of national security or the wellbeing of the organization and its staff/students, and has so been designated with a security classification.
- b. If any personnel come in possession or knowledge of information which is confidential in nature, the same shall not be disclosed. In case of termination or completion of tenure of MoU, all the relevant/sensitive information exchanged between the parties will be returned to the respective party or the parties in writing to ensure the security of such information.
- c. During the tenure of this MoU, both parties agree to maintain strict confidentiality of any information that the other Party has identified as confidential and will not disclose the same to any third party till such information falls into the public domain without negligence on the part of the recipient Party.
- d. In case of termination or completion of tenure of MoU, all the relevant/sensitive information exchanged between the parties will be returned to the respective party or the parties in writing to ensure the security of such information.

10. Validity

This MoU will be effective from the date is signed by both the parties and shall be valid for a period of **five (5) years** thereafter. The requirement for and duration of the renewal shall be reviewed on completion of the first tenure. The Joint Managers may by mutual agreement, at any time and subject to written ratification by the appropriate authorities of each party, modify the scope and the agreements under this MoU. Such modifications/amendments shall come into force from the day of signing of such modification.

11. Dispute Resolution

In case any dispute/claim arises between the parties w.r.t the MoU, including academic cooperation, validity, interpretation, implementation or alleged breach of any of its provision or regarding a question, including the questions as to whether the termination of this MoU by one party hereto has been legitimate, the parties here to shall endeavor to settle such dispute amicably through mutual discussions between the higher officer of the organizations. The amicable settlement shall be undertaken by the higher offices of the parties in order to undertake "genuine and good faith settlement" to resolve the dispute.

12. Termination

Either party may, on giving "**Current Academic Session or Six Months period whichever is later**" notice in writing, propose to foreclose this MoU or renegotiate its conditions.

13. Miscellaneous

a. Notices

All Notices given pursuant to this MoU shall be in writing and shall be delivered to the Parties at respective addresses as stated herein above in the MoU or to the respective email IDs as provided herein below:

- ii. Email ID of DAV University, Jalandhar – vc@davuniversity.org

- b. This MoU is not intended to provide any basis for investment or partnership decision at the present or in the future by and between the Parties, outside the scope of this MoU.
- c. Neither party may, nor cause any other party to, engage in any form of corruption or illegal or unethical act to obtain and maintain a business; including but not limited to: offering or paying a bribe or giving a gift or anything else of value to any official to

improperly influence anyone in connection with their obligations hereunder. Neither party shall engage in or tolerate any kind of bribery and shall not promise, offer, provide, or authorize anything of value; including without limitations; payments, gifts, travel, meals, entertainment, political contributions, and contributions of any kind of nature, such as donations and sponsorships or favors, to any Government official to improperly influence any act or decision-making in violation of applicable law. Neither party shall request, authorize, or tolerate any kind of bribery or any other kind of illegal or unethical action from others on behalf of the other party, in the other party's name, or in any way related to the services.



d. The students enrolled through CWA shall not be entitled to any other scholarship offered by DAV University, Jalandhar.

14. This MoU constitutes the entire understanding between the Parties and supersedes any and all prior or contemporaneous understandings and agreements whether written oral between the Parties with respect to the subject matter thereof.

15. This MoU is signed in duplicate with each copy being an official version and having equal legal validity.

16. The Parties, hereby agree to the foregoing MoU, which shall be effective immediately upon full execution by the signatories listed below:
