

MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

CENTRAL RESERVE POLICE FORCE FAMILY WELFARE ASSOCIATION (CWA)
AND
CAREER LAUNCHER EDUCATE LIMITED, BADARPUR, NEW DELHI

1. Parties

This Memorandum of Understanding (MoU) is executed between the **Central Reserve Police Force Family Welfare Association (CWA)**, represented by its President (Honorably addressed as 'The President CWA' and hereinafter referred to as the "**First Party**"), having its address at Directorate General, CRPF, Block No.1, CGO Complex, Lodhi Road, New Delhi-110003;

AND

Career Launcher Educate Limited, First Floor, A-45, NH-19, Block B, Mohan Cooperative Industrial Estate, Badarpur, New Delhi-110044 (hereinafter referred to as the "**Second Party**").

The First Party and the Second Party shall hereinafter be collectively referred to as the "**Parties**" and individually as a "**Party**".

2. Objectives

This MoU aims to:

- (a) Establish a formal framework for cooperation between CWA, its regional branches (RCWA), and Career Launcher Educate Limited.
- (b) Promote the **welfare of CRPF personnel and their families**, including the wards of serving, retired, martyr, injured, deceased, and gallantry awardee personnel, through the provision of educational and coaching programs.

3. Scope of Collaboration

The Parties agree to collaborate as follows:

- (a) Career Launcher shall extend exclusive benefits on educational coaching programs across all its centers in India.

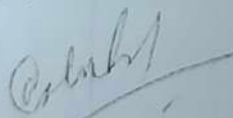
Eligibility:

Open to all active personnel, retired personnel, and families (including NoKs of martyrs and deceased CRPF personnel).

How to Avail:

Present a **valid CRPF ID card, service proof or casualty certificate / document certifying martyrdom / death in harness** (To be issued by nearest GC/Unit) at the time of registration.

- (b) Joint conduct of educational programs for wards and families of CRPF personnel.




4. Agreement for Collaboration

This MoU shall act as a **framework for mutual cooperation**. It does not create any financial or legal obligations on either Party. Any detailed agreements or addenda will be drafted and executed separately, with mutual consent and signature by authorized representatives.

5. Administration

(a) Joint Manager:

Each Party shall appoint one Joint Manager.

- CWA will be represented by its Secretary.
- Career Launcher will be represented by its Executive Vice President.

(b) Managers:

Each Joint Manager may **nominate personnel to coordinate and execute individual programs** under this MoU.

6. Salient Features of the Programs

- (a) Families of CRPF personnel will be offered various educational courses by Career Launcher.
- (b) The programs shall cover **wards/families of martyrs, injured, gallantry awardees, deceased, and retired/serving personnel**.
- (c) Eligibility requires successful completion of **Class 10 or 12** or equivalent from a recognized board.
- (d) Admission will be granted **subject to seat availability, fulfillment of eligibility criteria,** and adherence to Career Launcher's academic regulations.

7. Programme Benefits

Long-Term Courses (1 & 2 Year):

- **25% discount** on LST Span, LST Plus, IPMAT Span, IPMAT Plus, MBA Classic Extended.

Short-Term Courses (Crash):

- **25% discount** on CUET Express, IPM Express, MBA Express.

Special Benefit:

- **100% fee waiver** for families of CRPF personnel who **died in harness or attained martyrdom** in the line of duty.

8. Sharing of Facilities

Both Parties may allow **mutual use of facilities** on a case-to-case basis under mutually agreeable terms to promote educational cooperation.

9. Confidentiality

- (a) Confidential information includes any material designated under national security or other regulations requiring restricted access.
- (b) No personnel shall disclose any confidential information. Upon termination or expiry of the MoU, such material must be returned or securely disposed of.
- (c) Both Parties agree to **strict confidentiality** during the MoU's term, and such obligations shall survive termination until the information enters the public domain.

10. Validity

This MoU shall be effective **from the date of signing** and shall remain valid for **three (03) years**. Modifications may be made by mutual consent and written ratification by both Parties. Renewal will be reviewed at the end of the initial term.

11. Dispute Resolution

In case of disputes arising from the **interpretation, implementation, or termination** of this MoU, both Parties shall **endeavor to resolve them amicably** through mutual discussions by their senior officers.

12. Termination

Either Party may terminate this MoU by giving **six (06) months' written notice**. However, **students already admitted or projects already underway shall be allowed to complete their course/work** as per existing terms.

13. Miscellaneous

(a) Notices:

All notices shall be in writing and delivered to the Parties at the addresses mentioned in the MoU or through the following emails:

- **Career Launcher:** ashish.bahri@careerlauncher.com

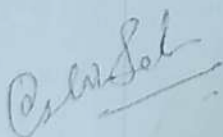
(b) This MoU **does not constitute a partnership or investment agreement**.

14. Execution

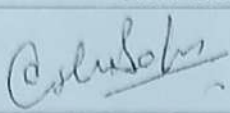
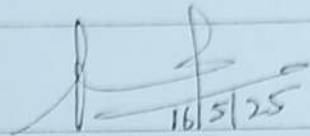
This MoU is executed in duplicate. Both copies are **equally valid and binding**.
