

MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

CENTRAL RESERVE POLICE FORCE FAMILY WELFARE ASSOCIATION (CWA)
AND
PHYSICS WALLAH FOUNDATION (PW FOUNDATION)

1. Parties

This Memorandum of Understanding (MoU) is executed between the **Central Reserve Police Force Family Welfare Association (CWA)**, represented by its President (Honorably addressed as 'The President CWA' and hereinafter referred to as the "**First Party**"), having its address at Directorate General, CRPF, Block No.1, CGO Complex, Lodhi Road, New Delhi-110003;

AND

PW Foundation, a not-for-profit company incorporated under the Companies Act 2013, having its principal office at Plot No. B-8, Tower A, 101-119 Noida One, 1st Floor, Sector 62, Noida, Uttar Pradesh - 201309 represented by its Head and Director (hereinafter referred to as the "**Second Party**").

The First Party and the Second Party shall hereinafter be collectively referred to as the "**Parties**" and individually as a "**Party**".

2. Objectives

This MoU aims to:

- (a) Establish a formal framework for cooperation between CWA, its regional branches (RCWA), and PW Foundation.
- (b) Promote the **welfare of CRPF personnel and their families**, including the wards of serving, retired, martyr, injured, deceased, and gallantry awardee personnel, through the provision of educational and coaching programs.

3. Scope of Collaboration

The Parties agree to collaborate as follows:

- (a) **PW Foundation**, directly or through its associate companies like Physics wallah Limited, shall extend exclusive benefits on educational coaching programs across all its centres in India and all online platforms as detailed in **Annexure A**.

Eligibility:

Open to all active personnel, retired personnel, and families (including NoKs of martyrs and deceased personnel) of CRPF.




How to Avail:

A. Category 1–Families/wards of Martyrs & personal died in harness(Deceased during service) (100% Scholarship)

1. Eligibility:
Wards or immediate family members of CRPF personnel who have attained martyrdom or died in harness while in service.
2. Process to Avail:
 - Applicants must complete the designated Google Form, selecting the "Martyr" category.
 - They are required to provide personal and academic details and upload relevant documentation, including:
 - a. Casualty certificate or
 - b. Document certifying martyrdom / death in harness (issued by the nearest GC/Unit)
 - c. Any other valid supporting service document, as applicable.
3. Verification:
All submitted documents will undergo verification by the authorized representative(s) of CRPF and or the implementation partner Physics wallah.
4. Access to Program:
Upon successful verification, the beneficiary shall be granted 100% scholarship and will receive access credentials to the program accordingly.

B. Category 2 – Families/wards of Serving/Retired CRPF Personnel (35% Scholarship for offline courses & 25% Scholarship for online courses)

1. Eligibility:
Wards or family members of currently serving or retired CRPF personnel.
2. Availing Process:
 - Applicants must complete the designated Google Form, selecting the "Serving/Retired" category.
 - They are required to provide personal and academic details and upload one of the following documents:
 - a. Valid CRPF ID card (for serving personnel)
 - b. Service certificate
 - c. Retirement certificate or PPO (for retired personnel)
3. Verification:
The submitted details and documents shall be subject to verification by the designated authority.

4. Access to Scholarship:

4.1. For Online Courses:

Upon successful verification, a 25% scholarship discount code will be generated and sent to the applicant's registered mobile number. This code can be used during the enrollment process on the online platform.

4.2. For Offline Courses:

The applicant shall be required to visit the PW Centre and enroll using the same mobile number provided in the application form. A 35% scholarship will be applicable on the tuition fee at the centre. The enrollment process at the centre will be completed after verification of applicant's identity and eligibility via the submitted form details.

4. Agreement for Collaboration

This MoU shall act as a **framework for mutual cooperation**. It does not create any financial or legal obligations on either Party. Any detailed agreements or addenda will be drafted and executed separately, with mutual consent and signature by authorized representatives.

5. Administration

(a) Joint Manager:

Each Party shall appoint one Joint Manager.

- CWA will be represented by its Secretary.
- PW Foundation will be represented by its Head and Director.

(b) Managers:

Each Joint Manager may **nominate personnel to coordinate and execute individual programs** under this MoU.

6. Salient Features of the Programs

(a) Families of CRPF personnel will be offered various educational courses by PW Foundation or its associate companies including Physics wallah Ltd.

(b) The programs shall cover **wards/families of martyrs, injured, gallantry awardees, deceased, and retired/serving personnel**.

(c) Admission will be granted **subject to seat availability, fulfilment of eligibility criteria**, and adherence to academic regulations of PW Foundation and its associate companies.

(d) **Note:** The fee waiver and discount are applicable only on tuition fee and not on other fee like boarding, lodging etc. or on any physical study material

7. Sharing of Facilities

Both Parties may allow **mutual use of facilities** on a case-to-case basis under mutually agreeable terms to promote educational cooperation.

8. Confidentiality

- (a) Confidential information includes any material designated under national security or other regulations requiring restricted access.
- (b) No personnel shall disclose any confidential information. Upon termination or expiry of the MoU, such material must be returned or securely disposed of.
- (c) Both Parties agree to **strict confidentiality** during the MoU's term, and such obligations shall survive termination until the information enters the public domain.

9. Validity

This MoU shall be effective **from the date of signing** and shall remain valid for **three (03) years**. Modifications may be made by mutual consent and written ratification by both Parties. Renewal will be reviewed at the end of the initial term.

10. Dispute Resolution

In case of disputes arising from the **interpretation, implementation, or termination** of this MoU, both Parties shall **endeavour to resolve them amicably** through mutual discussions by their senior officers.

11. Termination

Either Party may terminate this MoU by giving **six (06) months' written notice**. However, **students already admitted or projects already underway shall be allowed to complete their course/work** as per existing terms.

12. Miscellaneous

(a) Notices:

All notices shall be in writing and delivered to the Parties at the addresses mentioned in the MoU or through the following emails:

(b) This MoU does **not constitute a partnership or investment agreement**.

(c) **No bribery or unethical conduct** shall be tolerated. Both Parties shall comply with applicable laws and reject any form of corruption.

(d) This MoU constitutes the **entire understanding** between the Parties regarding the subject matter.

13. Execution

This MoU is executed in duplicate. Both copies are **equally valid and binding**.



14. Effective Date and Consent

The Parties agree to the terms stated in this MoU. It shall be **effective** immediately upon **signature** by the authorized representatives.
