



MEMORANDUM OF UNDERSTANDING (MoU)

Between

CRPF FAMILY WELFARE ASSOCIATION (CWA)

&

MADE EASY Education Private Limited (MEPL)

1. Parties

CRPF FAMILY WELFARE ASSOCIATION (CWA) duly registered under the Societies Act 1860, having its address at Directorate General, CRPF, Block No.1, CGO Complex, Lodhi Road, New Delhi-110003, represented by its Secretary Shri Pauly P.P., DIG (Welfare), Directorate General, CRPF New Delhi; hereinafter referred to as "**First Party**".

MADE EASY Education Private Limited (MEPL), registered under the Companies Act 1956, having its corporate office at 44A/1, Kalu Sarai, Sarvapriyavihar, New Delhi - 110016, hereinafter referred to as "**Second Party**".

2. Objectives

- (a) To establish a formal framework for cooperation between CWA, its regional branches (RCWA), and MADE EASY Education Private Limited (MEPL)
- (b) Promote the welfare of CRPF personnel and their families, including the wards of serving, retired, martyr, injured, deceased, and gallantry awardee personnel, through the provision of educational and coaching programs.

3. Scope of Collaboration

The Parties agree to collaborate as follows:



4. Agreement for Collaboration

This MoU shall act as a framework for mutual cooperation. It does not create any financial or legal obligations on either Party. Any detailed agreements or addenda will be drafted and executed separately, with mutual consent and signature by authorized representatives.

5. Administration

(a) Joint Manager:

Each Party shall appoint one Joint Manager for smooth functioning & execution of this MoU.

- CWA will be represented by its Secretary.
- MEPL, will be represented by its Chief Manager.

(b) Managers:

Each Joint Manager may nominate personnel to coordinate and execute individual programs under this MoU.

6. Salient Features of the Programs

- (a) Wards/Spouse of CRPF personnel shall be provided scholarships on ESE, GATE, SES, PSUs courses offered by MEPL.
- (b) The programs shall cover wards of martyrs, injured, gallantry awardees, deceased, retired and serving personnel.
- (c) Admission will be granted as per the admission policies & procedures of MEPL subject to seat availability, fulfillment of eligibility criteria etc.

7. Scholarship Offered

NOTE : The scholarship/discount shall be applicable only to the Foundation & Short Term (classroom & Online) courses and will NOT be applicable on Postal Courses, Publication Books, Test Series, Interview Guidance Programs etc.		

Procedure to avail the Scholarship

1. Interested aspirants are advised to thoroughly understand the course features available on our website or by consulting our career counselors at our office.
2. Produce a valid CRPF ID card.
3. Submit a document certifying martyrdom/casualty/death in harness, if applicable.
4. The beneficiary will be granted the scholarship upon successful verification of the documents.
5. Fill out the admission form for the desired course and pay the discounted fee.
6. It's advisable to read & understand all the terms & conditions related to admissions/course before taking the admission.

Important Clauses

3. **Non-Transferability:** The scholarship/discount offered under this MoU shall be non-transferable and shall be availed only by the eligible beneficiary.
4. **Verification of Documents:** MADE EASY reserves the right to verify all submitted documents and may reject the scholarship request in case of false, incomplete, or unverifiable information.
5. **Right to Amend:** MADE EASY reserves the right to modify course structure, fee structure, or related policies, provided that the scholarship terms under this MoU remain unaffected.

9. Confidentiality

- (a) Confidential information includes any material designated under national security or other regulations requiring restricted access.
- (b) No personnel shall disclose any confidential information. Upon termination or expiry of the MoU, such material must be returned or securely disposed of.
- (c) Both Parties agree to strict confidentiality during the MoU's term, and such obligations shall survive termination until the information enters the public domain.

10. Validity

This MoU shall be effective from the date of signing and shall remain valid for **Two (02) years**. Modifications may be made by mutual consent and written ratification by both Parties. Renewal will be reviewed at the end of the initial term.

11. Dispute Resolution



12. Termination

Either Party may terminate this MoU by giving **one (01) month** written notice. However, students already admitted or projects already underway shall be allowed to complete their course/work as per existing terms.

3. As per mutual understanding, MADE EASY may request CRPF officers to visit its centers to motivate students and to join in felicitating top rankers of GATE, UPSC Engineering Services Examination (ESE) & UPSC Civil Services Examination (CSE).




