JSW PROJECT

1. JSW company collaboration with CRPF give opportunity to NOKs and wards of martyrs/deceased to undertake job oriented courses like Beauty and Wellness, Media and Entertainment, Computer Education, Hardware & Networking courses organise by Aptech Company free of cost at various centres of country for NOK and wards of martyrs/deceased CRPF Personnel. Families & wards of serving personnel may also get advantage to take part in these courses free of cost if sufficient number of NOK and wards of martyrs/deceased not available to take part in these courses. Preference will be given to the NOKs of martyrs/deceased for undergoing these courses free of cost.

2. Beside above, funds provided by JSW Company will be used for Silai course meant for NOKs and family members of martys/deceased and serving force personnel to be conducted by Usha International Limited. In this regard an agreement has also been signed between CRPF Family Welfare Association and Usha International Limited on 27/09/2019 and its execution date is 20th January 2020.

3. CRPF Wives Welfare Association (CWA) with motto 'Sarthak Sahyog Sarvada' is a registered NGO committed to look after the families of martyrs and Central Reserve Police Force personnel who are away from home while serving the Nation in different distant locations and conflict zones such as J&K, LWE Areas, North East etc. The aim of CWA is to uplift and support the families of CRPF personnel and mitigate their problems. Hence Various companies of JSW remitted total Rs. 4,99,15,860.06 (Four Crore Ninety Nine Lakhs Fifteen Thousand Eight Hundred Sixty and six Paise) into the account of CRPF Wives Welfare Association (CWA), for further disbursement as per requirement.

4. A corpus of Rs. 4,50,00,000/- (Four Crore Fifty Lakh) only out the fund received from JSW Company has been created by fixing in a nationalised bank on 20/07/2019. Remaining amount Rs. 49,15,860.06 (Forty Nine Lakh Fifteen Thousand Eight Hundred Sixty and Six Paise) is being used for funding of courses fee of Aptech Company and for Usha International Limited alongwith other charges for conducting silai course in which **NOKs** of martyrs/deceased/families and wards of serving force personnel will participate in the year (2019-20).

5. Yearly Interest so generated from this corpus will be used for funding of courses in which NOKs of martyrs/deceased/families and wards of serving force personnel will participate in above mentioned courses from next year onward.

6. The aim and objects mentioned in booklet of CWA at Para-3(c)&(e) says "to pursue programmes to facilitate development of academic/vocational skill, training for the serving and retired CRPF personnel and their families" & to raise funds for various welfare schemes affecting the well being of CRPF families". Therefore, following are hereby issued to implement the scheme:-

i. <u>NAME :-</u>

a. The scheme will be called as "JSW PROJECT".

ii. OBJECT OF THE SCHEME :-

- a. Funding of fee of various job oriented courses like Beauty and Media and Entertainment, Computer Wellness, Education, Hardware & Networking courses organise by Aptech Company for NOK and wards of martyrs/deceased CRPF Personnel. families & wards of serving personnel may also get advantage to take part in these courses free of cost if sufficient number of NOK and wards of martyrs/deceased not available to take part in these courses. Preference will be given to the NOKs of martyrs/deceased for undergoing these courses free of cost.
- **b.** Funding as per agreement signed between CRPF Family Welfare Association and Usha International Limited on 27/09/2019 and its execution date is 20th January 2020. Silai course meant for NOK and family members of martys/deceased and serving force personnel to be conducted by Usha International Limited.

iii. GENERATION OF FUND :-

a. A sum of Rs. 4,50,00,000/- (Four Crore Fifty Lakh) only fixed in a nationalized bank and utilize its accruing interest only. While utilizing the fund it is to be ensured that corpus Rs. 4,50,00,000/- remains unchanged and only interest generated from it shall be used as per objectives of the project.

iv. MAINTENANCE OF RECORDS:-

a. The fund will be remained in the account of CWA and maintained through existing cash book of CWA and making a separate register in the name of scheme i.e **"JSW Project**" of CWA for its proper accounting.

v. <u>ELIGIBILITY:-</u>

- **a.** The scheme served as per the availability of fund and first come first serve basis.
- **b.** Any other expenses, if deemed fit and with the approval of JSW Company and governing body & CEC of CWA
- **c.** GC/Institute, which is organising the programme, will ensure to inform each office of campus, so that maximum force personnel and their families get advantage.

vi. <u>HOW TO APPLY:-</u>

- **a.** Sector/GC/institute will forward A formal proposal to this Dte for releasing funds under this project with all details.
- **b.** Competent authority of Dte. CRPF will forward the case to CWA for releasing of Fund.

vii. <u>POWERS TO THE MANAGING COMMITTEE</u>:-

a. The Governing body of CWA will decide the matter on top priority so that fund could be distributed within time frame and courses could be conducted regularly. Powers to amend the rule rests with the governing council of CWA with approval of the President CWA.
