

MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

CENTRAL RESERVE POLICE FORCE FAMILY WELFARE ASSOCIATION (CWA)

AND

AAKASH EDUCATIONAL SERVICES LIMITED

This Memorandum of Understanding (MoU) is executed on 3rd day of July, 2025 ("Execution Date") at New Delhi and effective from 3rd day of July 2025 by and between

CENTRAL RESERVE POLICE FORCE FAMILY WELFARE ASSOCIATION duly registered under the Societies Act 1860, having its address at Directorate General, CRPF, Block No.1, CGO Complex, Lodhi Road, New Delhi-110003, represented by its Secretary Shri Pauly P.P., DIG (Welfare), Directorate General, CRPF New Delhi (hereinafter referred to as the "**CWA**") being the party of the FIRST PART;

AND

AAKASH EDUCATIONAL SERVICES LIMITED, a company incorporated under the provisions of the Companies Act, 1956 having its corporate office at the 3rd Floor, Incuspaze Campus- 2, Plot No.13, Sector- 18, Udyog Vihar, Gurugram, Haryana- 122015, through its authorized representative Mr. Vipin Chand Joshi- Chief Financial Officer (hereinafter referred to as the "**AESL**" which expression shall unless repugnant to the meaning of context thereof mean and include its authorized representatives and permitted assigns) PARTY OF THE SECOND PART.

The CWA and AESL shall hereinafter be collectively referred to as the "**Parties**" and individually as a "**Party**".

WHEREAS:

- i. AESL is engaged in the field of providing coaching for NEET, IIT-JEE, entrance exams for medical & Engineering courses, Foundation courses, and other Junior level competitive exams and has developed its own methodology for imparting coaching to students who aspire to qualify for the said examinations/competitions.
- ii. For the welfare of the CRPF personnel and their families, the CWA and AESL are desirous of entering into this MoU for providing benefits to the students who wish to enrol for the courses offered by AESL at its various centres/branches located at PAN India.

NOW, THEREFORE in consideration of the promises extended by the Society/Trust and the mutual covenants hereinafter set forth, the Parties hereby agree as follows:

1. OBJECTIVES

This MoU aims to:

- a. Establish a formal framework for cooperation between CWA, its regional branches (RCWA) located PAN India and AESL.
- b. To promote the welfare of CRPF personnel and their families, including the wards of Martyr, deceased, injured, gallantry awardee, retired and serving personnel ("**CRPF Personnel**"), in pursuance of the same AESL shall be offering various scholarships on the courses offered by AESL at its branch/centres located at PAN India.
- c. This MoU shall act as a framework for mutual arrangement between the Parties. It does not create any financial or legal obligations on either Party.

2. SCOPE OF MOU

The Parties agree to collaborate as follows:

- a. **ELIGIBILITY:** AESL shall offer various scholarships to the CRPF Personnel on the courses offered by AESL at its branches/centres.
- b. **SCHOLARSHIPS OFFERED TO THE CRPF PERSONNEL:**

S. No.	Category	Scholarship offered by AESL
1	Combat Martyrs and deceased (death while on duty)	Only the registration fee is payable, and 100% waiver on all other components of the course fee.
2	Personnel having major disability	100% waiver only on the tuition fee component of the total course fee
3	In service personnel, gallantry awardee and retired	22% waiver on the tuition fee component out of the total course fee*

* The **22% waiver** will be given on the amount of the tuition fee component payable by the CRPF Personnel after deduction of the scholarships offered under various other scholarship programmes of AESL. This scholarship is over and above the scholarship programmes of AESL.

c. **CLAUSE ON LOWEST AND EXCLUSIVE PRICING PROTECTION**

AESL at its discretion has offered the scholarships or preferential pricing to the CRPF personnel. These discretionary scholarships are offered to the CRPF personnel by AESL in good faith and in the best interest of CRPF personnel keeping in mind the welfare of the wards of the CRPF personnel. These discretionary scholarships are the most favourable and is offered based on the trust and mutual consensus.



- d. **AVAILMENT OF SCHOLARSHIP BY CRPF PERSONNEL:** At the time of enrolment for the course at AESL branch/centre, the CRPF Personnel shall present a valid CRPF ID card, service proof or battle casualty certificate/document certifying martyrdom/ death in harness (any type of death while on duty) issued by the nearest Group Centre or Unit of CRPF. It is agreed between the Parties that in the event the CRPF Personnel fails to present any requisite document at the time of enrolment at the AESL branch/centre, AESL shall not be liable to provide any scholarship after the ward of the CRPF Personnel is enrolled with AESL at any branch/centre.
- e. For the administration of this MoU, the below mentioned designated personnel of the Parties shall act as managers:
- i. **Secretary of the CWA**
 - ii. **Head of Admissions for AESL**
- The above mentioned managers may nominate any other personnel to coordinate and administer the operations under this MoU.
- f. It is mutually agreed between the Parties that the CRPF Personnel shall abide by the terms and conditions of the AESL available at <https://www.aakash.ac.in/termsconditions>.
- g. **MENTORING, COUNSELLING AND SPECIAL SESSIONS:** During the Term of the MoU, AESL shall extend comprehensive mentoring and counseling support to the wards and CRPF Personnel, addressing both academic and career-related queries and AESL shall have the right to conduct seminars, counselling sessions, workshops at the 78 stations of CWA (including RCWA) located PAN India and the schools of CRPF located PAN India. CWA shall extend its full cooperation to conduct such seminars, counselling sessions, and workshops. The CRPF Personnel shall send any queries related to the purpose of this MoU at the email id as may be provided by AESL from time to time and AESL shall resolve such queries in a timely manner. Further, AESL also agrees to organize additional special mentoring, counselling, and outreach sessions for CRPF Personnel through virtual and physical platforms on a mutually agreed date and time.

3. PUBLICITY RIGHTS

- a. CWA will facilitate AESL to:
- i. Display and advertise related to the courses offered by AESL to the CRPF Personnel at various events organised by the CRPF or CWA for its personnel.
 - ii. Display and advertise related to the courses offered by AESL to the CRPF Personnel at various fests, annual days, and celebrations organised by CRPF or CWA for its personnel.



- iii. Display, advertise and publicize the execution of this MoU between the Parties in local daily(s), newspaper and media (including but not limited to social media, print media).

4. CONFIDENTIALITY

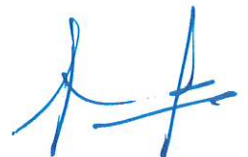
Parties agree to keep and secure all information to be kept secret and confidential and disclosed under this MoU, including to which the Parties has or gains access at any time during the Term of this Agreement or which is available to the Parties directly or indirectly, whether in writing, oral, graphic, visual or any other tangible, intangible or electronic form ("Confidential Information"). Parties agree to indemnify each other for any breach of any terms and obligations under this clause.

5. TERM AND TERMINATION

- a. This MoU shall be effective from the Effective Date and shall remain valid for a period of **three (03) years** unless terminated by either Party as per the terms and conditions of this MoU. This MoU may further be renewed in writing in accordance with such terms and conditions as may be mutually agreed between the Parties.
- b. Either Party may terminate this MoU by giving **two (02) months'** written notice to the other Party. However, the wards of the CRPF Personnel who have already enrolled with AESL and availed the as per their eligibility prior to termination/expiry of this MoU shall remain valid and AESL shall not revoke such scholarship unless ward of such CRPF Personnel has committed a breach of the terms and conditions of AESL as mentioned under clause 2(f) of this MoU.

6. DISPUTE RESOLUTION & GOVERNING LAWS

- a. The Parties agree that this MOU shall be construed in accordance with the laws in force in India and in the eventuality of any dispute or difference arising out of any matter related to the present MOU, the same shall be referred to the arbitration within 60 days of either Party notifying the other Party to the MOU of such dispute, for adjudication under the provisions of Arbitration & Conciliation Act, 1996. Parties hereby mutually agree to appoint a sole arbitrator for adjudication of disputes between the Parties, whose decision shall be final and binding upon the Parties. The sole Arbitrator shall conduct the **arbitration proceedings at Delhi**.
- b. It is also agreed between the Parties that arbitration proceedings would be conducted in English only and in no other language.
- c. That the Courts at Delhi shall have exclusive jurisdiction (subject to the arbitration proceedings which are to be also conducted at Delhi) over any or all disputes arising out of this MOU and the Parties hereby submit themselves to the jurisdiction of such Courts and/or Tribunals.



7. MISCELLANEOUS

a. **NOTICES:**

All or any notice or communication given by one Party to the other under this MoU or otherwise shall be considered duly served if it is sent by hand, registered post, email or courier at such Party's address herein after provided or at such other changed address of which prior notice is provided to the other Party:

b. **RELATIONSHIP:** The relationship of the Parties is that of independent contractors. Nothing in this MOU shall be construed as creating a partnership, joint venture, employer-employee, agency or other special relationship between the Parties.

c. **MODIFICATION:** No amendment, modification or addition to this MOU shall be effective or binding on either of the Parties hereto unless set forth in writing and executed by them through their duly authorized representatives.

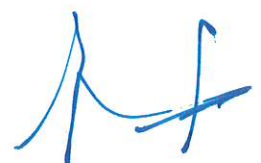
d. **ANTI-CORRUPTION:**

i. The Parties agree to conduct all their dealings in a very ethical manner and with the highest business standards. The Parties agree to adopt appropriate processes to prevent offering any illegal gratification in the form of bribes or gifts either in cash or in kind in the course of all dealings under this MOU.

ii. Each Party warrants and undertakes that:

(a) it will comply with all applicable laws, statutes, regulations and codes relating to anti-bribery and anti-corruption including but not limited to the Prevention of Corruption Act, 1988 ("Relevant Requirements"); and

(b) it has and shall maintain in place throughout the term of this MOU all policies and procedures necessary to ensure compliance with the Relevant Requirements.



- e. This MoU constitutes the entire understanding between the Parties regarding the subject matter.

8. EXECUTION

This MoU is executed in duplicate. Both copies are **equally valid and binding**.
