**MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called as "MOU") is entered into on this the 09th November 2023 MoU by and between.

Kongunadu College of Engineering and Technology(Autonomous), the First Party represented herein by its The Chairman of Kongunadu Educational Charitable Trust and **The Group Centre, CRPF, Avadi, Chennai**. The Second party, and represented herein by The Deputy Inspector General, CRPF.

WHEREAS:

- A) First Party is a Higher Educational Institution named: **Kongunadu College of Engineering and Technology(Autonomous)**,
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
- C) The Parties intend to cooperate and focus their efforts on cooperation Industrial Visits and promotion of research and development, providing seats in higher educational programmes for the wards of CRPF and CRPF Officers/personnel.
- D) **The Group Centre, CRPF** - The Second Party is engaged in providing an opportunity for B.Tech./B.E., engineers to associate with COMMUNICATION / INFORMATION technologies used in CRPF, internship projects on mutually beneficial areas would be worked out on case to case basis..

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party's co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2

SCOPE OF THE MoU

2.1 Admission to B.E./B.Tech., Programme.

CRPF (represented by DIG, GC, CRPF) personnel will be provided yearly 02 (Two) assured seats for admission in B.E, B.Tech., and M.E., Engineering Professional Educational programme from **Kongunadu College of Engineering and Technology (Autonomous)** in various programmes subject to pick the seats through the counseling mode and all other academic regulations of KNCET.

2.2 Financial Provisions, Boarding and Lodging

The candidates selected for Professional Educational programme shall not pay the tuition fee. However hostel accommodation and messing facility can be availed based on payment basis. Additional expenses like Examination fees, if any, incurred specific to the project shall be met by the candidate on their own.

2.3 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

CLAUSE 3

VALIDITY

3.1 This Agreement will be valid for a period of five (05) academic years (2024-2025 to 2029-30) thereafter. modifications / amendments shall come into Force from the day of signing of such modification.

CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES






