



MEMORANDUMOFUNDERSTANDING (MoU)

BETWEEN

CENTRAL RESERVE POLICE FORCE, (REPRESENTED BY THEDEPUTYINSPECTORGENERAL, GCCRPF, GANDHINAGAR) AND THE TRUSTEE BAPU GUJARAT KNOWLEDGE VILLAGE GANDHINAGAR-MANSA HIGHWAY, at VASAN, Dist-GANDHINAGAR-382650)

- 1 Parties:-The parties to this Memorandum of Understanding (MoU) are the Group Centre, CRPF, Gandhinagar (Gujarat) represented by the DIGP (herein after called "CRPF") having its address at GROUP CENTRE CRPF, Chiloda Road, Gandhinagar (Gujarat)-382042 and THE TRUSTEE BAPU GUJARAT KNOWLEDGE VILLAGE GANDHINAGAR represented by the Director (hereinafter called "BAPUGKV") having its address at GANDHINAGAR-MANSA HIGHWAY, at VASAN, Dist-GANDHINAGAR-382650). These entities are collectively referred to as the "Parties" and individually as a "Party" as the case may be.
- 2 Objectives:-This Memorandum of Understanding (MoU) is a imedto:-
- a Provide a formal basis for initiating interaction between CRPF and "BAPUGKV".
- **b** Promote academic cooperation, enhance scientific understanding of technologies related to internal security and undertake research in mutually beneficial areas.
- 3 Agreements for Collaboration. :- This MoU shall serve as an aegis for carrying out interaction in the areas of mutual interest with CRPF and offer Educational Programmes forwards / families of CRPF personnel (Through GC CRPF GNR). The signing of this document does not entail any financial or legal obligation on either party. Essentially, this MoU is a framework within which subsequent agreements, replete with financial implications and relevant details can be signed, for carrying out specific research and undertaking focused studies for resolving a particular technical issue oral levitating a technical problem. The terms and conditions of any such MoU/Agreements/Addendum etc. subsequent to this MoU shall be exchanged and discussed in detail by the representatives of both the parties prior to signing or executing.
- 4 Administration: This will be in two tiers as mentioned below:-
- a **Joint Managers**: Each party will be represented by one person to act as the Joint Manager of this MoU. Commandant, GC CRPF GNR will act as the Joint Manager for CRPF while Professor-in-Charge (External Relations) will act as the Joint Manager for "BAPUGKV".

- **Managers**:-Each Joint Manager may nominate appropriate personnel to manage the details of activities related to execution of individual programmes signed under this master agreement.
- 5 Conduct of Professional Educational Programmes, details of seats reserved and concession to CRPF candidates:-
- Admission to the following courses will be reserved for CRPF (represented by DIG, GC, CRPF and GANDHINAGAR) wards/families, subject to their clearing the interview and fulfilling the eligibility criteria and all other academic regulations of "BAPUGKV", under sponsored category. However, in case of non-availability of requisite number of candidates from the CRPF wards / families, "BAPUGKV" will not claim any loss from CRPF:-

b If appropriate numbers of students are not enrolled in the institute for the said courses, the institute will have the right to terminate the respective course/branch. In this circumstance CRPF will not claim for any admission.

- **,6 Sharing of Facilities:** Both CRPL and "BAPUGKV" shall allow the sharing of facilities as per the following arrangements.
- **a** Visits by representatives of CRPF to "BAPUGKV" for initiating and undertaking joint projects on mutually agreed terms.
- **b** Visits by faculty, students and researchers of "BAPUGKV" for initiating and undertaking joint projects (if feasible) by mutually agreed terms.
- c CRPF and "BAPUGKV" of Institutions shall make provisions to share their respective facilities on case to case basis and mutually agreeable terms in order to promote academic and research interaction in the areas of cooperation.
- 7 Confidentiality:
- Classified/confidential information means information or material, regardless of its form, that in accordance with the laws, regulations or policies of a Party requires protection in the interests of national security and has been so designated with a security classification.
- **b** If any personnel come in possession or knowledge of information which is confidential in nature, the same shall not be disclosed. In case of termination or completion of tenure of MoU, all the relevant/sensitive information exchanged between the parties will be returned to the respective party or the parties in writing to ensure the security of such information.
- **c** During the tenure of this MoU, both Parties agree to maintain strict confidentiality of any information that the other Party has identified as confidential and will not disclose the same to any third party till such information falls into the public domain without negligence on the part of the recipient Party.
- 8 Validity:-This MoU will be effective from the date is signed by both the parties and shall be valid for a period of three (03) years. Thereafter, the requirement for and duration of the renewal shall be reviewed on completion of the first tenure. The Joint Managers may by mutual agreement, at any time and subject to written ratification by the appropriate authorities of each party, modify the scope and the arrangements under this MoU. Such modifications/amendments shall come into Force from the day of signing of such modification:
- **9** Intellectual Property Rights (IPR):- Any Intellectual Property Rights (IPR) for work done as part of research under this program shall be jointly owned by CRPF and "BAPUGKV". The rights may be subsequently transferred to CRPF on mutually agree able terms on case to case basis.
- 1 <u>Dispute Resolution</u>:-In case of any dispute/claimer is between the parties w.r.t. the MoU, including academic cooperation, validity, interpretation, implementation or alleged breach of any of its provision or regarding a question, including the questions as to whether the termination of this MoU by one party here to has been

legitimate, the parties here to shall endeavor to settle such dispute amicably through mutual discussions between the higher officer of the organizations. The amicable settlement shall be undertaken by the higher offices of the parties in order to undertake "genuine and good faith settlement" to resolve the dispute.

10. **Termination:** Either party may, on giving 'six months' notice in writing, propose to fore close this MoU or renegotiate its conditions. In such cases, the team that has commenced project under this MoU should be allowed to complete the work adhering to the applicable conditions.

1 Group of Institutions:-

- a This MoU is not intended to provide any basis for investment or partnership decision at the present or in the future by and between the Parties, outside the scope of this MoU."
- Neither party may, nor cause any other party to, engage in any form of corruption or illegal or unethical act to obtain and maintain a business; including but not limited to; offering or paying a bribe or giving a gift or anything else of value to any official to improperly influence anyone in connection with their obligations hereunder. Neither party shall engage in or tolerated any kind of bribery and shall not promise, offer, provide, or authorize anything of value; including without limitations; payments, gifts, travel, meals, entertainment, political contributions, and contributions of any kind of nature, such as donations and sponsorships or favors, to any Government official to improperly influence any act or decision-making in violation of applicable law. Neither Party shall request, authorize, or tolerate any kind of bribery or any other kind of illegal or unethical action from others on behalf of the other party, in the other party's name, or in any other way related to the services.
- This MoU constitutes the entire understanding between the Parties and supersedes any and all prior or contempt or anions understandings and agreements whether written or oral between the Parties with reference to the subject matter hereof.

 This MoU is signed in duplicate with each copy being an official version and having equal legal validity.
