MEMORANDUM OF UNDERSTANDING (MoU)
BETWEEN
Central Reserve Police Force
(Represented by President RCWA)
AND
Dr. CV Raman University Bilaspur (C.G.)

I. Parties

The parties to this Memorandum of Understanding (MoU) are the Group Centre, CRPF family Welfare Association (RCWA) represented by its president (hereinafter Called RCWA) having its address at GC, CRPF, Bharni, Bilaspur (CG-495112) and the Institution represented by the Registrar having its address Dr. CV Raman University Campus, Kargi Road, Kota Bilaspur, Chhattisgarh (hereinafter called "CVRU"). These entitles are collectively referred to as the "Parties" and individually as a "Party" as the case may be.

2. Objectives

This Memorandum of Understanding (MoU) is aimed to:-

A. Provide a formal basis for initiating interaction between CWA/ its regional branches called RCWA and CVRU.

B. Welfare of wards of personnel through RCWA by offering Technical Education to their wards. RCWA is a non-profit organization run for the serving and retired CRPF families including that of the Martyrs and deceased Central Reserve Police Force personnel.

3. Plan

It is envisaged that RCWA and CVRU shall collaborate through the following:-

A. Visits by faculty, students and other staff of CVRU to establishments/Units of CRPF for the purpose of creating awareness and understanding of the CRPF among the youth of the country.

B. Any other mode of interaction or communication related to spreading awareness of both institutions in areas and communities of mutual interest.

C. Conduct of Technical education, including boarding where required and offered, as well as other educational services for wards/families of CRPF personnel.

4. Agreements for Collaboration:

This MoU shall serve as an aegis for carrying out interaction in the areas of mutual interest with RCWA and offer technical education for wards / families of CRPF personnel (through RCWA). The signing of this document does not entail any financial or legal obligation on either party. Essentially, this MoU is a framework within which activities shall be planned with the mutual consent of both parties and through which wards of CRPF families shall be nominated and admitted to CVRU. This MoU also provides the framework within which any subsequent agreements, replete with financial implications and relevant details can be signed if deemed necessary by the parties.

5. Administration:

Each party will be represented by one person to act as the Joint Manager of this MoU. Secretary RCWA will act as Joint Manager for RCWA while Mr. Gourav Shukla will act as the registrar of CVRU.

6. Salient Features:

The Educational Programmes have the following salient features:-

A. Families of CRPF Personnel through RCWA will be offered admission in CVRU based on the ages and eligibility of the wards for Educational Curriculum.

B. It will be open to wards / families of martyred, retired, and serving CRPF personnel.


C. Admission to the College:-


- I. Wards / Families of Martyr, Retired and Deceased CRPF personnel (recommended by the "Chhattisgarh Sector CRPF") will be offered 10 free seats in all the UG and PG programme, wherein we will be waiving 100% Tuition Fees. Also as well for the Wards /Families of Martyrs, Retired and Deceased CRPF, CVRU is offering 10 seats with a concession of 75% in the Tuition Fees of the technical and professional curriculum subject to availability of seats in the University. Wards / Families of serving CRPF personnel (as recommended by "Chhattisgarh Sector CRPF") 05 seats with concession of 25% in Tuition Fees in all the UG & PG programme. Wards / Families of serving CRPF personnel (as recommended by "Chhattisgarh Sector CRPF") 05 seats with concession of 50% in Tuition Fees in Technical & Professional curriculum programme. The admission of any wards to the University shall always be subject to an interview with the academic staff, fulfilling the eligibility criteria and all other regulations of CVRU.
- II. CRPF Wards, who secured admission to all UG through concerned Entrance test will be given 100% waiver in Tuition Fee.

7. Financial Implications on Wards Enrolled in the University:

A. Financial Provisions:

The wards enrolled in the 10 free seats shall not pay any Tuition fees. The accommodation in the hostel is provided free of charge to the 05 seats. However, there are expenses associated with food and

other variable costs, such as electricity and maintenance, which need to be paid separately.

B. Transport, Cafeteria, Boarding:

Wards opting to avail the following facilities shall do so on a payment basis, subject to availability:

- (i) Transport to and from the Campus on the University Busses.
- (ii) Food provided in the cafeterias.
- (iii) Other auxiliary services offered by the University.

8. Sharing of Facilities:

Both RCWA and CVRU shall allow the sharing of facilities as per the following arrangements:-

A. Visits by faculty, students and staff of CVRU to CRPF through RCWA for spreading awareness and understanding of the CRPF and its role in the history and importance to the future of the nation by mutually agreed terms, if feasible.

B. CRPF through RCWA and CVRU shall make provisions to share their respective facilities on case to case basis and mutually agreeable terms in order to promote academic interaction in the areas of cooperation.

9. Confidentiality:

A. Classified/Confidential information means information of material, regardless of its form, that in accordance with the laws, regulations or policies of a Party requires protection in the interests of national security or the wellbeing of the organization and its staff/students and has so been designated with a security classification.

B. If, any personnel come in possession or knowledge of information which is confidential in nature, the same shall not be disclosed. In case of termination or completion of tenure of MoU, all the relevant/sensitive information exchanged between the parties will be returned to the respective party or the parties in writing to ensure the security of such information.

- C. During the tenure of this MoU, both parties agree to maintain strict confidentiality of any information that the other Party has identified as confidential and will not disclose the same to any third party till such information falls into the public domain without negligence on the part of the recipient Party.
- D. In case of termination or completion of tenure of MoU. All the relevant/sensitive information exchanged between the parties will be returned to the respective party or the parties in writing to ensure the security of such information.

10. Validity:


This MoU will be effective from the date is signed by both the parties and shall be valid for a period of 05 Academic years thereafter. The requirement for and duration of the renewal shall be reviewed on completion of the first tenure. The Joint Managers and the Registrar may be mutual agreement, at any time and subject to written ratification by the appropriate authorities of each party, modify the scope and the arrangements under this MoU. Such modifications / amendments shall come into force from the day of signing of such modification.


11. Dispute Resolution:

In case any dispute/claim arises between the parties with reference to the MoU, including academic cooperation, validity, interpretation, implementation or alleged breach of any of its provision or regarding a question, including the questions as to whether the termination of this MoU by one party hereto has been legitimate, the parties here to shall endeavor to settle such dispute amicably through mutual discussions between the competent officer of the organizations. The amicable settlement shall be undertaken by the competent offices of the parties in order to undertake "genuine and good faith settlement to resolve the dispute".

12. Termination:

Either party may, on giving "**Current Academic Session or Six Months period whichever is later**" notice in writing, propose to foreclose this MoU or renegotiate its conditions.

14. This MoU constitutes the entire understanding between the Parties and supersedes any and all prior or contemporaneous understandings and agreements whether written oral between the Parties with respect to the subject matter thereof.

15. This MoU is signed in duplicate with each copy being an official version and having equal legal validity.
