WELLNESS & EDUCATION ECO SYSTEM

CRPF Wives Welfare Association (CWA) with motto 'Sarthak Sahyog Sarvada' is a registered NGO committed to look after the families of martyrs and Central Reserve Police Force personnel who are away from home while serving the Nation in different distant locations and conflict zones such as J&K, LWE Areas, North East etc. The aim of CWA is to uplift and support the families of CRPF personnel and mitigate their problems.

- 2. During the meeting held on 05/03/2020, Governing Body and CEC members of CWA decided to create a new scheme named "Wellness Education **Eco System**" to provide assistance to Group Centres/Institutes for organising wellness education classes/ courses or training for wellbeing and eradicate stress level of officers/Jawans and their family members. Centres/Institutes may contact with various renowned agencies as Ayush, Naturopathy, Art of living etc. for giving training/education to the officers/Jawans and their family members within the premises of CRPF Campus. scheme we will also provide financial assistance for organising various Coaching, Career counselling, smart classes and courses for a group of students of CRPF serving/retired/Martyrs & deceased personnel. CWA will bear the expenses of wellness & education classes/courses through the scheme "Wellness Education Eco System" only once in a year.
- 3. To run the scheme a sum of Rs. 1,99,99,990/- (One Crore Ninety Nine Lakh Ninety Nine Thousand Nine Hundred Ninety) out of the donation received for welfare of jawan from all over India, will be fixed in a nationalised bank and interest generated from it will be used to run the scheme.
- 4. The aim and objects mentioned in booklet of CWA at Para-3(c)&(e) says "to pursue programmes to facilitate development of academic/vocational skill, training for the serving and retired CRPF personnel and their families" & to raise funds for various welfare schemes affecting the well being of CRPF families". Therefore, following are hereby issued to implement the scheme:-

i. <u>NAME :-</u>

a. The scheme will be called as "Wellness Education Eco System".

ii. OBJECTIVES OF THE SCHEME :-

d. To provide assistance to Group Centres/Institutes for organising wellness education classes/ courses or training for wellbeing and eradicate stress /anxiety level of officers/Jawans and their family members. Group Centres/Institutes may contact with various renowned agencies as Ayush, Naturopathy, Art of living etc. for giving training/education to the officers/Jawans and their family members within the premises of CRPF Campus.

e. Through the scheme we will also provide financial assistance for organising various Coaching, Career counselling, smart classes and courses for a group of students of CRPF serving/retired/Martyr & deceased personnel.

iii. **GENERATION OF FUND:-**

a. A sum of Rs. 1,99,99,990/- (One Crore Ninety Nine Lakh Ninety Nine Thousand Nine Hundred Ninety) will be fixed out of CWA fund in one of the nationalized bank and utilize its accruing interest only. While utilizing the fund it is to be ensured that corpus Rs. 1,99,99,990/- remains unchanged and only interest generated from it shall be used to bear expenses of organising wellness & education classes/courses. This year interest will be Rs.12,06,365/-.

iv. MAINTENANCE OF RECORDS:-

a. The account will be maintained through existing cash book of CWA and making a separate register in the name of scheme i.e "Wellness Education Eco System" of CWA for its proper accounting.

v. **ELIGIBILITY:-**

- a. The scheme served as per the availability of fund and first come first serve basis.
- b. Funds for the said scheme will be released wef April 2021 as interest of fixed deposit will be generated during the March 2021. Accordingly cases under this scheme will be considered wef next financial year 2021-22 and so on.
- c. Through the scheme CWA will bear expenses as per the availability of funds for organising wellness courses/trainings for officers/Jawans and their family members, only once of a GC/Institute in a year.
- d. Through the scheme CWA will bear expenses as per the availability of funds for organising career counselling, coaching and for smart classes for a group of students/children, only once of a GC/Institute in a year.
- e. Any other expenses, if deemed fit and as per approval of governing body on the Education/Wellness.
- f. GC/Institute, which is organising the programme, will ensure to inform each office of campus, so that maximum force personnel and their families get advantage.
- g. No fund will be provided for refreshments under this scheme.

vi. HOW TO APPLY:-

- a. A formal information and approval of President CWA is required before organising the programme under this scheme.
- b. Requisite fund details subject wise are required to be informed in advance.
- c. GC/institute will forward case to this Dte for releasing funds under this scheme with the recommendation of concerned sector office after completion the programme alongwith all requisite documents as details of Guest Speaker, details of participant brief details of the programme and all fund details.

vii. POWERS TO THE MANAGING COMMITTEE:-

a. The Governing body of CWA will decide the matter on top priority so that fund could be distributed within the same financial year. Powers to amend the rule rests with the governing council of CWA with approval of the President CWA.

viii. <u>DISTRIBUTION OF FUND</u>:-

- a. The fund will be disbursed into the account as asked by the GCs/institute.
- 5. Accordingly, all concerned are requested to comply these orders.
- 6. This is issued with approval of President, CWA.
