AMENDMENT ORDER (SPARSH-THE MOTHER'S TOUCH)

SOP of "Sparsh-The Mother's Touch" scheme issued vide this office order no. W-V-34/2019-CWA-Wel-II dated 27/11/2019 is amended as under:-

CRPF Family Welfare Association (CWA) with motto 'Sarthak Sahyog Sarvada' is a registered NGO committed to look after the families of martyrs and Central Reserve Police Force personnel who are away from home while serving the Nation in different distant locations and conflict zones such as J&K, LWE Areas, North East etc. The aim of CWA is to uplift and support the families of CRPF personnel and mitigate their problems. CWA always support the NOKs and families of CRPF martyrs to address their problems.

- 2. Post Pulwama incident lots of donation / contribution have been received from various organisations / NGOs / Individuals in CWA. During the meeting held on 07/11/19, Governing Body and CEC members of CWA decided to create a new scheme named "**Sparsh-The Mother's Touch**" to provide Rs. 2000/- to each new born girl child. To run the scheme a sum of Rs. 1,50,00,000/- (One Crore Fifty Lakhs) out of the donation received for welfare of jawan from all over India, fixed in a nationalised bank and interest generated from it will be used for distribution of Rs. 2000/- to new born girl child of officers/Jawans.
- 3. The aim and objects mentioned in booklet of CWA at Para-3(e) says "to raise funds for various welfare schemes affecting the well being of CRPF families, widows, handicapped and mentally retarded children and disabled personnel and families of retired personnel". Therefore, following are hereby issued to implement the scheme:-

i) **NAME :-**

The scheme will be called as "SPARSH-THE MOTHER'S TOUCH".

ii) OBJECTIVES OF THE SCHEME :-

To provide Rs. 2000/- to each new born gild child, whose date of birth falls wef 01/01/2021 onwards of CRPF personnel irrespective of their birth place and residence of parents as per the availability of fund generated on interest of FD invested in nationalized bank. Rs. 2000/- will be donated maximum of two girl child (first and second child) of each jawan. Amount of fund/donation can be reconsidered on the basis of no. of new born girl child and interest of fund generated on FD.

iii) **GENERATION OF FUND :-**

Fixed Deposit of Rs. 1.5 Crore out of CWA fund in one of the nationalized bank and utilized further from its reinvestment/ accruing interest. While utilizing the fund it is to be ensured that corpus Rs. 1.5 Crore remained unchanged and interest generated from it shall be used to provide Rs. 2000/- maximum of two girl child (first and second child) of each officer/jawan. The scheme served as per the availability of fund and first come first serve basis.

iv) MAINTENANCE OF RECORDS:-

The account will be maintained through existing cash book of CWA and making a separate register in the name of scheme i.e "SPARSH-THE MOTHER'S TOUCH" of CWA for its proper accounting.

(v) **ELIGIBILITY:-**

Each new born girl child, in respect of serving and deceased CRPF officers/personnel are eligible to provide assistance Rs. 2000/-through the scheme. However cases for providing financial assistance to new born girl child will be selected on the basis of pay scale of parents on receiving more cases than available fund under this scheme. Preference will be given to lower pay scale to higher pay scale drawing personnel. The financial assistance will be provided maximum to two living girl child i.e (first and second child) of each officer/jawan.

vi) **HOW TO APPLY:-**

The parents of eligible girl child may apply in a format attached in appendix "A" to the President CWA through respective RCWA along with birth certificate of child alongwith undertaking that the new born girl child is his first or second child. Thereafter, RCWA will send the applications of eligible and genuine candidates through their respective GC/Institution once in a year by 31st December positively. So the fund will be utilized within the same financial year. Concerned H.O.O or any other officer authorised by him will examine the birth registration certificate and will ensure its correctness before submitting the case to CWA office, New Delhi.

vii) POWERS TO THE MANAGING COMMITTEE:-

The Governing body of CWA consisting 6 members will decide the matter on top priority before 31st January of every year so that fund could be distributed within the same financial year. Powers to amend the rule rests with the governing council of CWA with approval of the President CWA.

viii) **DISTRIBUTION OF FUND:-**

Sanctioned fund will be remitted into WAF account of concerned GC/Units/Institution where individual is posted with the direction to open **Sukanya Samriddhi Account** in the name of new born girl child with this amount and same hand over to the parents.

To run the scheme a sum of Rs. 1,50,00,000/- (One Crore Fifty Lakhs) out of the donation received for welfare of jawan from all over India, will be fixed in a nationalised bank and interest generated from it will be used for distribution of Rs. 2000/- to new born girl child of officers/Jawans.
- 3. The aim and objects mentioned in booklet of CWA at Para-3(e) says "to raise funds for various welfare schemes affecting the well being of CRPF families, widows, handicapped and mentally retarded children and disabled personnel and families of retired personnel". Therefore, following are hereby issued to implement the scheme:-

i) **NAME :-**

The scheme will be called as **"SPARSH-THE MOTHER'S TOUCH"**.

ii) OBJECT OF THE SCHEME :-

To provide Rs. 2000/- to each new born girl child, whose parents are residing within the premises of CRPF during the birth of girl child as per the availability of fund generated on interest of FD invested in nationalized bank. Rs. 2000/- will be donated maximum of two girl child (first and second child) of each jawan. Amount of fund/donation will be reconsidered on the basis of no. of new born girl child and interest of fund.

iii) **GENERATION OF FUND :-**

Fixed Deposit of Rs. 1.5 Crore out of CWA fund in one of the nationalized bank and utilized further from its reinvestment/ accruing interest. While utilizing the fund it is to be ensured that corpus Rs. 1.5 Crore remained unchanged and interest generated from it shall be used to provide Rs. 2000/- maximum of **two girl child (first and second child) of each officer/jawan.** The scheme served as per the availability of fund and first come first serve basis.

iv) MAINTENANCE OF RECORDS:-

The account will be maintained through existing cash book of CWA and making a separate register in the name of scheme i.e "SPARSH-THE MOTHER'S TOUCH" of CWA for its proper accounting.

(v) **ELIGIBILITY:-**

The parents of eligible girl child may apply in a format attached in appendix "A" to the President CWA through respective RCWA along with birth certificate of child alongwith address proof and undertaking that the new born girl child is his first or second child. Thereafter, RCWA will send the applications of eligible and genuine candidates through their respective GC/Institution once in a year by 31st December positively. So the fund will be utilized within the same financial year.

vii) POWERS TO THE MANAGING COMMITTEE:-

The Governing body of CWA consisting 6 members will decide the matter on top priority before 31st January of every year so that fund could be distributed within the same financial year. Powers to amend the rule rests with the governing council of CWA with approval of the President CWA.

viii) **DISTRIBUTION OF FUND:**-

The fund will be disbursed into the account of parent of new born girl child and concerned RCWA/institute will ensure remittance of amount.
