

MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding is signed at New Delhi on 19 September 2025

BY AND BETWEEN

CENTRAL RESERVE POLICE FORCE FAMILY WELFARE ASSOCIATION duly registered under the Societies Act 1860, having its address at Directorate General, CRPF, Block No.1, CGO Complex, Lodhi Road, New Delhi-110003, represented by its Secretary Shri Pauly P.P., DIG (Welfare), Directorate General, CRPF New Delhi (hereinafter referred to as the "CWA"); hereinafter referred to as "First Party".

Drishti Group (VDK Eduventures Pvt. Ltd., brand name: Drishti IAS), registered under the Companies Act and having its registered office at Mukherjee Nagar, New Delhi-110009, through its Board Member and Mentor, hereinafter referred to as "Second Party".

The CRPF Family Welfare Association in short known as CWA and Drishti Group are hereinafter collectively referred to as "**Parties**" and individually as "**Party**".

Whereas

The First Party, **CRPF Family Welfare Association (CWA)**, is entering into this MoU for the welfare of families of its serving and retired personnel, including personnel killed or wounded in action and physical casualties, for educational purposes.

The Second Party, **Drishti Group**, is engaged in providing coaching for competitive examinations including UPSC Civil Services, Judiciary, State PCS, Teaching Examinations, One-Day Examinations and Common University Entrance Test (CUET).

Purpose

The Parties are intended to collaborate for the coaching of Noks/Wards of Martyrs and those died in harness, serving CRPF personnel, ex-servicemen, their spouses and wards to help them pursue careers in civil services and other competitive examinations.

The Parties agree to enter into this Memorandum of Understanding under the terms and conditions stated below.

(b) Coaching/Preparation for Competitive Examinations

The Institute will provide specialised coaching in English and Hindi mediums for the following examinations:

- UPSC Civil Services Examination
- Judiciary Examinations
- State PCS Examinations
- Teaching Examinations
- Common University Entrance Test (CUET)
- One Day Examinations

(c) Eligibility and Document Verification

(i) At the time of enrolment for the course at branch/centre, the CRPF Personnel shall present a valid CRPF ID card, service proof or battle casualty certificate/document certifying martyrdom/death in harness (any type of death while on duty) issued by the nearest Group Centre or Unit of CRPF.

(ii) Spouses and Children: Dependent Identity Card.

(iii) It is agreed between the Parties that in the event the CRPF Personnel fails to present any requisite document at the time of enrolment at any branch/centre/Drishti Learning App, Drishti Group shall not be liable to provide any scholarship at the time of admission. In case any CRPF personnel, spouse, or ward purchases a course at full price due to lack of awareness about the scheme, Drishti Group shall have liberty to consider a refund on the amount .

(iv) All discounts under this MoU shall be applicable only to new admissions made after the date of signing of this MoU.

11. Terms and Conditions

(a) The Second Party shall offer the course programs mentioned in Clause 10 for a period of three years at the agreed discounted rates.

(b) The discount may be extended to additional courses based on mutual viability.

(c) The Second Party shall not use the name, insignia, or premises of CWA or imply endorsement by CWA unless expressly authorised in writing.

(d) In the event that any eligible CRPF personnel, spouse, or ward purchases a course at full price without availing the discount under this MoU, the Second Party shall not be held responsible for

15. Tenure and Termination

- (a) This MoU shall be effective from the date of signing and shall remain valid for three years, i.e., from the Academic Year 2025-26 to 2027-28, and may be renewed upon mutual review.
- (b) Either Party may terminate the MoU by giving three months' written notice.
- (c) In case of termination, all students already enrolled under this MoU shall continue to receive benefits until completion of their respective courses.

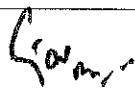
