(.) As per extant Govt. Guidelines, they will continue to draw the salary and perks/ allowances as per their entitlement in their parent organization (.) The equivalent grade in HCL is only for regulation of administrative aspects such as delegation of powers, entitlement of tour/transfer, quarter allotment, medical facilities etc (.) The equivalent grade in HCL shall remain unchanged during deputation period of three years (.) During the period of deputation, they will be governed by the standard Terms and Conditions for appointment of Officers from CAPF on deputation in HCL, as conveyed vide HCL's letter dated 21-07-2025 (enclosed) (.) Para (.) MHA vide their CF- 3797002 (CRPF) dated 16/06/2026 has accorded their approval for relieving of above officers for deputation to HCL subject to the following terms and conditions :-

(i) Formal approval/consent of the competent authority has been granted to relieve the concerned officer for deputation for a period of three years, subject to the fulfilment of the prescribed terms and conditions upon their selection.

(ii) Other service conditions and allowances for the deputation will be regulated in accordance with the provisions of DoP&T OM dated 17-06-2010 and the MHA deputation policy dated 24-11-2016.

(iii) Before relieving the officers, it must be ensured that no disciplinary or vigilance case is pending or under consideration against them.
