- 3. The financial implication on Cadre Review of Group 'A' posts for net creation of 90 posts as mentioned above comes to Rs.12.68 Crores. An approval has accorded by the Government to surrender/abolish 230 posts of Head Constables (Radio Operator/Crypto) and 216 posts of Constable (Bugler) to make the proposal revenue neutral. The matching savings to surrender the above 446 posts also comes to Rs.12.68 Crores.
- 4. The upgraded/newly created posts will come into existence from the date/dates these are filled up. The appointments to the posts sanctioned above would be made in accordance with the rules/regulations governing such appointments. These posts shall carry their usual pay and allowances as per orders issued by Govt. of India from time to time.
- 5. The expenditure involved during the current financial year will be met from within the sanctioned budget grant of the Central Reserve Police Force for the current financial year 2016-17.
