In the mean while 07 personnel of C/74 & D/74 were got bullet injury have been provided first aid by first aider and evacuated to Raipur with the help of helicopter for further treatment. Out of which No. 981340034 HC/GD Ram Maher of D/74 attained Martyrdom during enroute. However due to continuing of heavily fire by naxals 24 more personnel of D/74 attained Martyrdom and one more persl (No.135061389 CT/GD Sonwani Ishwar Suresh) was got bullet injury and naxals managed to escape by looting of personal weapons and VHF sets of Martyred jawans due to thick forest and undulating terrain. On receipt of information, Dig (Ops) Dwa rushed to the Burkapal camp and supervised the situation/operation. Due to prompt action and proper co-ordination with all troops, all the Martyred jawans a/w one injured persl have been recovered and shifted to Burkapal camp and further evacuated to Raipur with the help of helicopter for further course of action. Our party (i.e C/74 & D/74) reached their coy location Burkapal at 1955 Hrs.
