MEMORANDUM OF UNDERSTANDING

BY and BETWEEN

GROUP CENTRE-1, CENTRAL RESERVE POLICE FORCE, AJMER

AND

INVENTORS EDU PRIVATE LTD, IPA Building, Neeti Marg, Near Ajmer Club, AJMER

This Memorandum of Understanding (MoU) is made and entered into on 22nd March 2025, by and between:

1. Group Centre-1, Central Reserve Police Force (CRPF), Ajmer, under the Ministry of Home Affairs, Government of India, hereinafter referred to as GC-1Ajmer, which is committed to the welfare of its personnel and their families, and
2. INVENTORS EDU PVT LTD AJMER, a reputed coaching institution with expertise in providing quality education and training for competitive examinations, hereinafter referred to as Coaching Partner.

Both parties collectively referred to as the parties, hereby agree as follows:

1. Objective

The objective of this MoU is to facilitate the education and career advancement of the wards of CRPF martyrs and the wards of serving/retired CRPF personnel by providing them with reserved seats and financial concessions in the courses offered by the Coaching Partner.

2. Terms of Understanding

A. Reservation of Seats

The Coaching Partner agrees to reserve for each course offered:

1. 30 seats for the wards of CRPF martyrs.
2. 30 seats for the wards of serving/retired CRPF personnel.

B. Fee Concession

The Coaching Partner agrees to provide a fee concession of:

1. 80% for the wards of CRPF martyrs in the Overall Fee.
2. 50% for the wards of serving/retired CRPF personnel in the Overall Fee.

3. Duration and Renewal

This MoU shall remain valid for a period of two years from the date of signing and may be renewed upon mutual agreement between both parties.

4. Responsibilities of GC-1 CRPF Ajmer

GC-1 Ajmer shall identify wards of martyrs and recommend eligible candidates for the reserved seats as per the agreed terms.

It shall facilitate communication and coordination between CRPF families and the Coaching Partner.

GC1 Ajmer would allow the Coaching Partner to conduct seminars and market about their courses in its campus without any charges.

5. Responsibilities of the Coaching Partner

The Coaching Partner shall ensure the quality of education and training provided to the selected candidates.

It shall not discriminate against any beneficiary under this MoU.

It shall provide necessary academic support, guidance, and mentorship to the enrolled students.

It shall clearly state the concessions provided in the tuition fee and the overall fee.

6. General Terms

This MoU does not create any legally binding obligations other than those explicitly mentioned.

Any disputes arising under this MoU shall be resolved amicably through mutual discussions.

Both parties may terminate this MoU by providing a written notice of 30 days in advance.

7. Signatories
