Objective of EOI

CRPF intends to upgrade its existing Enterprise Web Application. The application includes automation of all official activities / processes of CRPF covering HRMS, Administration, Establishment, Payroll & Finance, Provisioning, Inventory, Logistics, Fleet, Assets (Building and Land), CRPF Operational activities, GIS, Intelligence, Legal, Medical etc.

An Expression of Interest (EOI) is floated to identify a futuristic technology, approach and methodology for prospective solution, best suited to transform our existing setup as per standards conforming to latest industry norms. Interested firms / agencies are advised to study objectives as mentioned under before preparing their response to the EoI.

System Integrator are requested to proposed best proven technology architecture for development of Web application as per the Govt of India Policy (Open Source with Enterprise Support) and also have to propose methodology for development & implementation in their response.

Current System (Web Application) :

An Integrated web application was developed in the year 2004 on VB, ASP with Oracle as back end database on a monolithic architecture. Subsequently with the time, various processes have been upgraded to ASP.Net & Core.Net technology using the available resources. Currently Oracle 19c is being used for database.

The existing set up is hosted on a web based architecture on a captive network. Data Centre is located at Force HQ Delhi. Data is being captured through following Modules in an integrated environment.

(1) Personnel Information System (PIS/HRMS)

- (2) Payroll application is client server based; developed in D2K
- (3) Inventory
- (4) Operations, Intelligence & GIS
- (5) Finance

- (6) Administration / Establishment
- (7) Legal
- (8) Training

Presently 425 offices are using current application through captive MPLS Intranet and approx. 1500 other remote offices are connected from Internet through Web-VPN services. Presently around 23,000 transactional users are accessing current application. Few functionalities of this applications are also extended through department Mobile App and approx. 3 Lac users are onboard on this Mobile Application.

Objectives of proposed Web Application:

Broad objectives of the future application are:

a) Preferably based on a microservices architecture.

b) Aiming to achieve a paperless office where necessary orders or letters are generated within the application.

c) Designed to be dynamic, scalable, and flexible to adjust to future business needs without requiring significant effort in case of changes to the organizational hierarchy.

d) Aligned with industry-standard GoI processes.

e) Built on a single-sign-on (SSO) framework.

f) Equipped with an inbuilt workflow system configurable according to the roles of employees.

g) Integrated using API-based communication within modules and with third-party applications.

h) Capable of hosting a repository for various documents and orders.

i) Capable of generating all types of reports (live and scheduled) from a secondary database, ensuring no load on live transactions. The proposed reporting engine will be embedded in the application (ERP), and data will be accessible to users based on their roles and hierarchy levels.
