



MEMORANDUM OF UNDERSTANDING BETWEEN CRPF ACADEMY GURUGRAM, HARYANA AND NATIONAL ACADEMY OF CUSTOMS INDIRECT TAXES AND NARCOTICS, FARIDABAD

The CRPF ACADEMY, Gurugram which is located at Kadarpur village, Haryana in the Republic of India represented by its Director, Shri Pankaj Kumar, ADG, CRPF under the administrative control of the Director General, CRPF, Shri A.P.Maheshwari, IPS which expression shall always include its successors or assignees or any organization or agency claiming any rights through it.

And

National Academy of Customs Indirect Taxes and Narcotics, Faridabad herein after referred to as NACIN which will be represented by its Addl. Director General Shri N. K.Upadhyay under the administrative control of the Principal Director General, NACIN Shri Devendra Singh, IRS which expression shall always include its successors or assignees or any organization or agency claiming any rights through it.

WHEREAS,

The CRPF Academy is an establishment of the Government of India under the Ministry of Home Affairs and Central Reserve Police Force. It is situated in Gurugram District of Haryana and has been in existence since October 2005. It is engaged in conduct of foundation training to Directly Appointed Gazetted Officers of CRPF selected through UPSC CPF AC Exam. It is also dedicated to train the officers of All India Service, Police Officers of all States and other

CAPFs under the aegis of BPR&D and DOP&T. CRPF Academy is committed to establish as nodal Trainer Development Centre for all CAPFs in terms of DOP&T courses. Around 900 Police Personnels are trained every year in various courses, which include Basic Training of DAGOs/DEGOs/MOs, Trainer Development Courses for officers, Operational/Specialised Courses, Combatisation training for IRS Officers, CBI Probationers etc.

Objectives of CRPF Academy:

- 1. To impart one year basic training to the Directly Appointed Gazetted Officers of the rank of Assistant Commandants and also various In-Service Course for officers of CAPFs.
- 2. To Conduct DOP&T training for officers of CAPFs.
- 3. To impart combatisation training to officers of other services like IRS(C&CE), CBI etc.
- 4. To undertake research, survey, case studies etc. and compile documents and to analyze the available literature relevant directly and indirectly to training etc.

WHEREAS

National Academy of Customs, Indirect Taxes & Narcotics (NACIN) is the apex institute of Government of India for capacity building in the field of indirect taxation. It also plays a vital role in international capacity building by imparting training to officers of various countries in the field of Customs, Drug Laws and Environmental protection. NACIN is the World Customs Organisation's (WCO) Regional Training Centre (RTC) for Asia Pacific region. United Nations Environment Program (UNEP) has designated NACIN as a collaboration centre for capacity building in the field of environment protection. In collaboration with United Nations Office on Drugs & Crime (UNODC), NACIN is imparting training on drug law enforcement to various Asian nations. The Government of India has entrusted NACIN with the responsibility of knowledge exchange, experience sharing and training with various countries of the world.

Over the years, NACIN has been successfully conducting professional training of the officers of Indian Revenue Service (Customs & Central Excise). It has been imparting in-service training to the officers of Government of India across several Departments in the field of Customs, Central Excise, Service Tax, Drug

Laws, Anti-Money laundering, Weapons of Mass Destruction, Fake Indian Currency Notes, Ozone Depleting Substances (ODS), Intellectual Property Rights (IPR) etc.

WHEREAS, both parties hereto are desirous into entering an agreement whereby they can collaborate and work together with each other in areas of mutual interest for mutual benefits and have reached the following understanding:-

- A- The parties will explore and work upon the development and promotion of research colloborations in the areas of mutual interest.
- B- The parties will facilitate exchange of faculty and resource persons for Academic and Research purpose.
- C- The parties will jointly develop and organise thematic short term training programms, Seminars, Conferences and workshops in the areas of mutual
 interest and in association with national/international industry partners.
- D- The parties will provide each other access to their academic publications and library resources.
- E- The parties will assist each other to progress on any matter of mutual interest.

NOW, THEREFORE both parties herein above have discussed the matter at an administrative and technical level, and have mutually agreed to enter into an agreement by this Memorandum of Understanding (MOU) on the following terms and conditions namely:-

- The parties shall jointly plan calender of events for holding seminars, workshops and short term courses to be conducted at the campus of either of the parties, depending upon the availability of the participants.
- Joint research projects in various related subjects will be undertaken, the terms and conditions for which, will be decided on mutual agreement between the parties.
- 3. Based on the need of CRPF Academy and NACIN, Faridabad, both the parties will ensure the participation of its faculty and scholars in training activities organised by the parties in its campus.

- 4. The transport facility and honorarium in respect of participants/trainers/faculty as per guidelines of the respective academies/parties existing at the time of lecture in respect of participants/trainers will be born by the respective parties.
- 5. This MoU shall not be a legally binding contract, and under no circumstances, this MoU will subject either of the parties to breach of contract, whether material or minor, or to any liability under national or international laws or to any other applicable law.
- 6. The parties hereby agree that they are not bound exclusively by this memorandum and shall be at liberty to enter into any separate agreement(s) with any third party without reference to the other party. However, each party may disclose similar arrangements they enter into with any third party.
- 7. All conditions, changes, amendments, waivers etc shall only be in writing, duly executed by both the parties.
- 8. There shall be a Steering Committee comprising of total four members (two representative members from each party) to resolve the differences and disputes arising in the implementation of this MoU. The members of the Steering Committee would consist of equal number of members from both parties.
- 9. This MoU and any amendment thereof, shall be limited to the purpose of this MoU.
- 10. The parties shall make best efforts to resolve all differences and disputes arising in connection with the implementation of this MoU amicably. In case the differences are not resolved amicably, the matter shall be reffered to the Steering Committee to resolve the differences which may lead to termination of this MoU.
- 11. This MoU shall remain valid for a period of five years from the date of its signing unless terminated earlier by serving written notice at least 30 days in advance by either party and may be renewed for another 5 years by mutual agreement of the parties at least 60 days prior to expiry of this MoU.
