



# MEMORANDUM OF UNDERSTANDING BETWEEN CRPF ACADEMY GURURGRAM, HARYANA AND SARDAR PATEL UNIVERSITY OF POLICE, SECURITY AND CRIMINAL JUSTICE, JODHPUR

### Between

The TRPF ACADEMY, Gurugram which is located at Kadarpur village, Haryana in the Republic of India represented by the Director / Additional Director General of Central Reserve Police Force Academy, Sh. Pankaj Kumar, which expression shall always include its successors or assignees or any organization or agency claiming any rights through it.

### And

Sardar Patel University of Police, Security and Criminal Justice, Jodhpur, herein after referred to as SPUP which will be represented by its Vice Chancellor Mr N.R.K. Reddy herein after referred to as SPUP which expression shall always include its successors or assignees or any organization or agency claiming any rights through it.

### WHEREAS,

The CRPF Academyis an establishment of the Government of India under the Ministry of Home Affairsand Central Reserve Police Force. It is situated in Gurugram District of Haryana andhas been in existence since October 2005. It isengaged inconduct of foundation training to Directly Appointed Gazetted Officers of CRPFselected through UPSC CPF AC Exam. It is also dedicated to train the officers of All India Service, Police Officers of all States and other CAPFs under the aegis of BPR&D and DOP&T. CRPF Academy is committed to establish as nodal Trainer Development Centre

for all CAPFs in terms of DOP&T courses. Around 900 Police Personnel are trained every year in various courses, which includes Basic Training of DAGOs/DEGOs/MOs, Trainer Development Courses for officers for officers, Operational/Specialised Courses, Combatisation training for IRS Officers, CBI Probationers etc.

## Objectives of CRPF Academy:

- 1. To impart one year basic training to the Directly Appointed Gazetted Officers of the rank of Assistant Commandants and also various In-Service Course for officers of CAPFs.
- Conduct of DOP&T training for officers of CAPFs.
- 3. Impart combatisation training to officers of other institutions like IRS(C&CE), CBI etc.
- 4. Undertake research, survey, case studies etc. and Compile documents and analyse the available literature relevant directly and indirectly totraining etc.

### **WHEREAS**

Sardar Patel University of Police, Security and Criminal Justice, Jodhpur (SPUP) has been established by an Act Passed by the State Legislature, Government of Rajasthan. The Act mandates the University to focus on teaching and research in the field of police, social sciences, criminal justice, public safety and security and other related areas. In a fast changing global scenario, there is an urgent need to focus on critical issues related to security, criminal justice, road safety, gender sensitisation, cyber crime and other related fields. Policy makers, academicians, researchers, social scientists, lawyers and police have a pivotal role in shaping the future of our nation with honesty, commitment and far ranging vision. SPUP is one such pioneering institute that provides a dynamic and intellectually invigorating environment to students, faculty and researchers alike to cater to the above mentioned needs. The University stresses on innovative solutions to the problems related to the above mentioned fields.

### Mission of SPUP

To create an academic centre of excellence dedicated to the study, research and extension activities in the realm, of Policing, Security and Criminal Justice where professionals, academicians and young citizen work together



to achieve understanding Knowledge and skills required to attain highest ideals of public services and Democratic Citizenship

Vision of SPUP is to provide an interdisciplinary academic environment for learning and research through programs that includes perspectives for Social Sciences, Humanities, Science & Technologies and Professional studies whereby students and professionals equip themselves with intellectual professional and moral competencies for combating the emerging challenges to security justice and public safety in free democratic and diverse society.

SPUP has many institutional linkages with various agencies in India to attain its mission, vision and objectives.

WHEREAS, both parties here to are desirous into entering anagreement whereby they can collaborate and work together with each other in areas of mutual interest for mutual benefits.

AND WHEREAS both parties have discussed the matter at an administrative and technical level, and have decided to enter into an agreement by this Memorandum of Understanding.

NOW, THEREFORE, the parties agree as follows:

- CRPF Academyand SPUP desire to establish collaborative relations between them to award Post Graduate Diploma in Police Administration and Internal Security to the Trainee officers of Academy.
- 2. Types of the certificate to be awarded by SPUP.

Both the Institutions agreed that:

- (a) The Basic Courses of Directly Appointed Gazetted Officers (DAGOs), which is a 52 weeks course approved by Ministry Of Home Affairs (MHA) will be recognised by the University for awarding certificate as Post Graduate Diploma in Police Administration and Internal Security (PGDPAIS).
- (b) Other serving officers of the CRPF can also enrol in the program through CRPF Academy and after completion of the evaluation, they will be awarded Post Graduate Diploma in Police Administration and Internal Security (PGDPAIS).



# 3. Syllabus of the Diploma Course.

The syllabus for the Diploma Courses shall be structured by the Teaching Faculty members of SPUP in consultation with CRPF Academy. In this process, new relevant concepts shall be added in the syllabus.

# 4. Formal Admission of the candidates in SPUP, Jodhpur

- (a) The candidates of the courses shall get formal admission in SPUP, through the procedure followed or instructed by the University as per the revision to be made from time to time.
- (b) The course fees, Examination fees, Certificate charges for each trainee officer(Directly Appointed Gazetted Officer) and other Serving officers of CRPF will be as per actuals issued by SPUP.

# 5. Teaching Sessions

The Faculty of CRPF Academy shall handle the courses according to their arrangement and the faculty members of SPUP shall handle the courses wherever necessary, after getting the due approval of authorities of the University and CRPF Academy.

## 6. Examination Procedures

CRPF Academy shall facilitate all candidates to apply for the course end examination, as per the procedure followed or instructed by the University as per the revisions to be made time to time.

# 7. Evaluation Procedures

The faculty members of SPUP will evaluate the Viva Voce, Project Reports, Solved answers of all 04 papersalong with the faculty members of CRPF Academy.

# 8. Qualifying Marks.

- (a) Toqualify, the candidate should get 50 per cent marks in all papers.
- (b) In the case of Viva-Voce, Presentation, and Projects, the average of both the internal and external evaluations shall be considered for deciding qualifying marks.





# 9. Award of Certificate / Diploma

- (a) The criteria for first class, and distinction shall be decided by University.
- (b) According to the percentage of marks obtained by the candidate, the certificate/diploma shall be awarded by the University.
- 10. Other than the Course: Internship attachment for Students, Faculty exchange Joint Workshops etc.
  - (a) CRPF Academy and SPUP shall mutually co-operate with each other in case of internship attachment for Students, Student visits, Faculty Exchange. Joint Workshopsetc.
  - (b) For the above mentioned joint activity programs between both the institutions, the planning for the conduct of the same shall be done well in advance and the roles and responsibility of institute shall be decided without any ambiguity during the planning of the activity.
  - (c) Endeavour to conduct annual workshops on a matter related to Policing, Internal Security with due mutual consent.

# 11. T. A, Accommodation and Honorarium to the Faculty Members

- (a) Boarding and lodging to the faculty members of SPUP, who visit CRPF Academy for the purpose at evaluation and other visits for the courses Shall be provided by CRPF Academy.
- (b) Boarding and lodging to the faculty members of CRPF Academy, who visit SPUP for the purpose of teaching /faculty exchange, shall be provided by SPUP.
- 12. The agreement shall become operative on signing and shall remain in force for an initial period of three years.
- 13. CRPF Academy and SPUP shall confer concerning the renewal of this Memorandum of Understanding six (6) months prior to the date of expiration.
- 14. Either institution may terminate this agreement by giving Twelve (12) months notice in writing to the other institution. Any joint programs that may have commenced at either institution before the

date of termination may be completed by special agreement between the institutions.

- 15. This Memorandum of understanding may be amended or revised by CRPF Academy and SPUP after mutual consultation and agreement.
- 16. This Memorandum of understanding will be constructed as instruments of intent to foster genuine and mutually beneficial Academic collaboration.
- 17. This Memorandum of Understanding shall not in any way prohibit the institutions from entering into similar Memorandum of Understanding with other universities or institutions
- 18. This Memorandum of Understanding is subject to the laws and regulations applicable to Indian law in any court.
- 19. For conditions not covered by this agreement, or for problems that arise during the course of this Memorandum of understanding, both parties agree to refrain from unilateral action and to consult and negotiate mutually acceptable decisions.
