

TERMS AND CONDITION TO BE FOLLOWED DURING THE PRIOD OF AGREEMENT FOR RUNNING OF
FISH/MEAT/VEGETABLE SHOP INSIDE THE GC CAMPUS

01. Quotation/application are invited for Running of Fish/Meat/Vegetable shop inside the GC CRPF Bhubaneswar Campus as per recommendation of assessment Board detailed by DIG Cum Estate Officer of GC CRPF Bhubaneswar.
02. Only these bidders will be permitted to attend the bidding process who submitted their applications by Post (Registered Post/Speed Post) on or before 20 /4/2021.
03. By hand applications will not acceptable.
04. Following details are required to be furnished in Application form
(a) Application should address to DIGP, GC CRPF, Nayapalli Bhubaneswar (b) Name of Applicant, (c) Residential Address, (d) Adhar Card No. (e) PAN Card No, (f) Bank Account Details with IFSC Code, MICR Code No. (g) Passport size recent Photo (h) Details of previous experience if any.
05. Permission to highest bidder who bids minimum Rs. 5000/- per month or more will be given on temporary basis as a Vendor for running of Fish/Meat/Vegetable Shop inside the GC CRPF Bhubaneswar Campus.
06. The entire bidding process and condition are available in web site **crpf.gov.in**. Before proceeding for bedding one can down load the terms and condition from above web site.
07. Before participate in bedding process, all are required to be deposited a sum of Rs, 15,000/- (Rupees Fifteen Thousand) only in cash as bidding security money.
08. The Security money will be refunded on same date to each unsuccessful bidder after completion of bidding process.
09. The amount of successful bidder may be adjusted as monthly rent and final security deposit.
10. Successful bidder will deposit a security Money amounting to Rs.1, 00,000/- (One Lac) only, which will refundable if agreement terminated at later stage.
11. After depositing the Final security Money, the agreement will be signed in between bidder and Chairman FWC.
12. If the successful bidder fails to deposit the Final security Money i.e. Rs, 1, 00,000/- within stipulated date and time, then his/her permission for running of Fish/Meat/Vegetable shop on temporary rental basis will stand cancelled and his/her bidding security will be forfeited.
13. On the approval of competent authority Second highest bidder may be offered permission.
14. The selected bidder will also be liable to pay the following charges on receipt of information from this office.
 - (a) Monthly fixed Rent of Buildings at a rate of Rs. 5000/- (Five Thousand) only per month.
 - (b) Water Charges at a Rate of Rs. 50/- per month.
 - (c) Sharing of monthly Profit to FLM Fund at a Rate of Rs. 5000/- per month
 - (d) Electricity charges (if used) in accordance with TPCODL authorities.

15. The selected bidder will maintain hygiene and sanitation of the Shop area as well as its surrounding area (including beatification).
16. The selected bidder will engage casual labour/sales man for selling of Fish/Meat/Vegetables etc. at their own cost.
17. Unwanted civilians except the permitted casual labour/Sales Man with bidder will not entered into the campus.
18. Vehicles Registration Number may also provided to this office issuing Gate Pass. Not more than Two (2) vehicles will be permitted.
19. Proper Gate Pass will issued by the designated officer of this Group Centre.
20. The Bidder and their casual labour/sales man will not involve in any indiscipline activities and maintain camp discipline.
21. A complaint/suggestion Book should be kept outside the shop and the same should be attended by the daily duty SO of this GC in right sprit and further report to DIG Cum Estate Officer for remedial action/betterment.
22. Daily sale rate chart should be displayed on the entrance of the outlet and a copy also be provided to this office for further checking.
23. Selected Vendor should obtained necessary permission Certificate from Bhubaneswar Municipality Corporation regarding selling of dressed chicken/fish etc.
24. DIG Cum Estate Officer is competent to cancel the agreement if he/she fails to obey the instructions as mentioned above, by serving three months notice and the bidder will also windup his business immediate after completion of period from the date of issue of such Notice.
25. Simultaneously if the Bidder wishes to close his/her business, he/she will intimate these facts to this Office before three months for winding up.
