G.S.R.....(E).- In exercise of the power conferred by sub-section (1) of section 18 of Central Reserve Police Force Act, 1949 (66 of 1949), the Central Government hereby makes the following rules further to amend the Central Reserve Police Force, Group 'B' posts (General Duty, Technical and Tradesmen Cadre) Recruitment Rules, 2014, namely:-

1. (1) These rules may be called the Central Reserve Police Force, Group 'B' posts (General Duty, Technical and Tradesmen Cadre) Recruitment (Amendment) Rules, 2021.

(2) They shall come into Force on the date of their publication in the Official Gazette.

2. In the Central Reserve Police Force, Group 'B' posts (General Duty, Technical and Tradesmen Cadre) Recruitment Rule, 2014, (hereinafter referred to as the said rules), for rule 10 (1), the following rule shall be substituted, namely:-

“10. Superannuation.- (1) The person appointed under these rules shall retire from service on the afternoon of the last day of the month in which he or she attains the age of sixty years :

Provided that the person whose date of birth is the first day of a month shall stand retired from service on the afternoon of the last day of the preceding month on attaining the age of superannuation.”;

3. In the said rules, in the Schedule,-

(a) (i) against serial number 3, relating to the post of Technical Cadre Sub-Inspector (Armourer), in column (11), under sub-heading “By promotion”,

for the entries relating thereto, the following entries shall be substituted, namely :-

“Assistant Sub-Inspector (Armourer) in level-5 (Rs. 29200-92300/-) in the pay matrix with six years regular service in the grade and who,-

(i) has passed pre-promotional or promotional course or courses prescribed by the Director General;

(ii) is in Medical category “SHAPE-ONE” ; and

(iii) has good record of service.”

- (b) (i) against serial number 4, relating to the post of Sub-Inspector (Motor Mechanic), in column (11), under sub-heading “By promotion”, for the entries relating thereto, the following entries shall be substituted, namely :-

“Assistant Sub-Inspector (Fitter) in level-5 (Rs. 29200-92300/-) in the pay matrix with six years regular service in the grade and who,-

(i) has passed pre-promotional or promotional course or courses prescribed by the Director General;

(ii) is in Medical category “SHAPE-ONE” ; and

(iii) has good record of service.”
