GENERAL INSTRUCTION:-

1. Reputed distilleries and Breweries (except bottling plant) or their authorized dealers/agents for supply of IMFL/FL/Beer/GIN/Wine satisfying the requirements of the tender may submit their tenders with complete documents as required.
2. The bids are to be submitted online, however, tender fee, Security Money and Tender sample needs to be sent physically so as to reach by the last day of submission of bids.

4. TENDER PROCEDURE:-

The online tenders are being called under two bid system consisting of technical bid (Cover 1) and financial bid (Cover 2).

COVER-1:-**THE FOLLOWING ARE REQUIRED TO BE SCANNED AND SUBMITTED THOROUGH THE CPP PORTAL:-**

- i. Scanned copy of PAN card.
- ii. Scanned copy of GST Registration.
- iii. Scanned copy of latest IT return of last three financial year.
- iv. Scanned copy of Tender cost as Rs. 500/- (Rupees five hundred) Only in the form of BD in favour of Liquor Canteen, GC CRPF Lucknow payable at SBI, CRPF Campus, Lucknow (IFSC Code- SBIN0017586)
- v. Scanned copy of valid registration/license for importing of raw materials, bottling, production and sale of liquor in India.
- vi. Scanned copy of Financial Stability Certificate form a Nationalized Bank up to the estimated cost of supply.
- vii. Scanned copy of Lab Test Report of the products offered under this tender (not older than 1 year) from a Govt. approved lab.
- viii. Scanned copy of Tender Documents duly completed and signed along with duly stamped on every page but without indicating the rates quoted.
- ix. Performa Appendix A to C.

COVER-2:-

Shall contain the Financial Bid on the prescribed BOQ, where the firm shall quote his offer for the products.

5. The online tenders will be opened on the due date and time and the documents submitted online will be evaluated by Board of Officers (BOO).
6. The tender samples of the firms (whose documents are found in order) will be tested and approved by a BOO (comprising of representatives from all ranks) and finally the price bid shall be opened as per the recommendation of the BOQ.
7. If the price of item or items are same in respect of two or more than two firms, then L-1 shall be of the Firm based on maximum items are L-1 out of these Firms.
8. The purchaser reserves the right to place on the successful Tender for additional quantity up to 25% of the quantity offered by them at the time of placement of order or during the currency of the contract.
9. The tender of the firms who fail to fulfill the eligibility conditions will be summarily rejected.
10. The bidders should keep checking the CPP portal as well as CRPF website for any corrigendum/addendum till the last date of submission of bids.
11. The terms and conditions shall be returned with signature of the authorized person while submitting the tenders. Tenderers will have to sign on all papers of the terms and condition.
12. The department will not be responsible for any delay in online submission of bids as well as the physical submission of Tender cost (non refundable), EMD (Security Money) and tender samples.
13. Any bidder declared bad performer/blacklisted by the Central/State Govt/Autonomous body/PSUs will be debarred.
14. If required, Price Negotiation may be done by the Competent Authority.
15. The performance Security would be required within 15 days from the date of issue of AT/confirmed supply order and would be released after the obligations of the firm are successfully met. The successful Tenderer shall be required to furnish an amount equal to 3% in the form of Bank Guarantee in favour of Liquor Canteen, GC CRPF Lucknow payable at SBI, CRPF Campus, Lucknow (IFSC Code- SBIN0017586) of the contract value as security deposit as guarantee against its own performance under the contract within 15 days of issue of contract. It should be valid up to 60 days beyond the expiry of Warrantee/Guarantee period. In case Performance Security is not deposited by the successful bidder within the stipulated time form the placing of Supply order/AT, irrespective of any reason, Security Money could be permanently forfeited and Supply order/AT would become liable for cancellation at the risk of the Firm.

16. The department shall accept the delivery of liquor made by the successful bidder only after proper inspection/Line Committee report and payment shall be made thereon.
17. The Security Money will be liable to be forfeited in case the tenderer refuses to accept the Supply Order placed/fails to supply within the prescribed time limit.
18. Duly labeled 02 sample bottles of each product/items of liquor (for which the firm is bidding) must be deposited with the DIG Group Center CRPF Lucknow (UP) before the last date of submission of the tender as Tender Sample. Samples will be tested and kept in record. Hence it will not be returned back.
19. The rates quoted by the firm are valid for one year from the date of acceptance of tender/start of supply. In any circumstances, the rate once quoted will not be enhanced. The DIG, GC CRPF, Lucknow reserves the right to re-consider the contract and if any need arises the contract will be terminated without assigning any reason thereof.
20. The cost of any breakage, theft etc. during transit of bottles including excise duty are to be borne by the firm.
21. Loading/unloading charges will be borne by the successful bidder.
22. The quantity of liquor can be increased or decreased by this office at any time during the currency of period i.e. 20/12/2021 to 31/03/2022.
23. All the liquor supplied shall be of the best quality confirming to the specification laid down for them in accordance with the approved standard.
24. All the rates quoted in the online tender should be for supplies at FOR destination i.e. DIG, Group Center CRPF, Lucknow (UP)-226002.
25. The successful bidder shall deliver the supply within 30 days from the date of Supply Order.
26. The earnest money of unsuccessful tenderers will be refunded within 60 days. No interest will be paid on earnest money of successful or unsuccessful tenderers.
27. To accept whole or part of quantity and articles tendered are at the discretion of DIG, Group Center, CRPF Lucknow and can also drop any items without assigning any reason thereof.
28. All legal proceedings arising out of this contract to be instituted by any of the party will be in jurisdiction of Lucknow (UP).
29. This tender is on no cost no commitment basis.
30. Conditional tenders will not be accepted. There will be no binding regarding quantity or a particular brand to be procured at any time.
31. Every bottle or other receptacle containing liquor that has been compounded or blended in India shall be labeled as having been compounded or blended in India. Every bottle or receptacle containing foreign spirits bottled in the state shall bear a label affixed to it by the bottler in accordance with the terms of his bottling license, No import of any brand from the distillery/brewery will be allowed in Uttar Pradesh without Holograms. Tenderers shall be responsible to procure and stick hologram on each bottle being imported in UP (in case of bottles the hologram shall be affixed in such a way that half of the hologram should be pasted on crown and half on the glass bottle so that it breaks with the opening of crown).
32. Liquor will be supplied only in glass bottles of 750 ML for RUM, Whisky, GIN, Vodka, Wine and Scotch. Beer shall be supplied in both glass bottles and can in case of beer.
33. In case the quantity of liquor supplied by the firms are not the same as per samples approved/selected at the time of entering into the agreement/contract, the DIG, Group Center, CRPF Lucknow will have the right to reject the consignment or to terminate the contract without assigning any reason thereof.
34. The decision of DIG, Group Center, CRPF Lucknow will be final as to the quality of the stores and shall be binding on the tenderer.
