INSTRUCTION / TERMS & CONDITIONS

(Tender are advised to read the instructions carefully before submitting their offer/ questions:-

01. The tender has to declare that the liquor as mentioned above supplied to the purchaser under this contract shall be of the best quality, workmanship and new in all respects and shall be strictly in accordance with the minimum specification and particulars contained / mentioned in the tender forms. if the said store are found not to confirm to the description and quality of aforesaid store will be rejected the decision of the purchaser in the behalf shall be final and binding on the firms and purchase should be entitle to call upon the tender to rectify or replace the stores within specified time.

ii) The purchaser shall be entitled to recover the cost with all expenses form the tender for such defective / inferior / damaged stores and same will be returned to firms concerned on freight to pay basis at their own risk and cost.

02. The purchase will not pay separately for transit insurance and the supplier will be responsible till the entire store delivered in full and good condition at the Commandant 173 Bn CRPF Airfield Dimapur (Nagaland). The suppliers will be responsible for any loss or damage to the stores that may occur during the transit.

03. The price quoted should be firms basis and including all deliver charges / sale tax / vat excise duty etc valid up to six Months At 173 Bn CRPF Airfield Dimapur (Nagaland) Clear shown separately on the quotations. the price should be quoted in rupees / paisa and quantity.

04. CST/GST/VAT/LC number of the firms should be clearly mentioned in the quotations.

05. The representative of the firms who responded to our tender enquiry can be present in HQ/ 173 Bn CRPF Airfield Dimapur (Nagaland) at the time of opening of tender on **27/01/2023 at 1200 hrs**

06. The firms who response to our tender notice should be produced the samples of the above store indicating all technical specification / feature should be sent along with questions or should produce while opening the tender on **27/01/2023**.

07. The tender should submit the following documents along with their quotations falling which their tender will be rejected. Photo copy of latest valid sale taxes clearance certificate not more than one year old. Preference if any will be given to the firms who have past experience of similar type of store.
08. Earnest Money deposit EMD to the tune of **Rs. 50,000** Only should be sent in the form of **CDR/FDR/BG/BC** of any nationalized bank in favor of Commandant 173 Bn CRPF Airfeild Dimapur (Nagaland) along with the quotations.
09. No interest shall be payable by the purchaser on the EMD deposited by the tenderers
10. EMD of un-successful tenderers will be returned back as early as possible. Hence Tenders are requested to send a pre receipt challan along with quotations, so that refund of EMD can be made well in time.
11. The tender / quotations may be sent by registered post / courier / speed post to commandant 173 Bn CRPF Airfeild Dimapur (Nagaland) by hand tender / quotations will not be entertained under any circumstances .
12. The tender which rate are approved have to deposit 2 to 5 % of the cost of stores as security Money. On receipt of the security money. EMD will be returned to the tender. Cash security deposit will not be accepted. the security deposit will be returned subject to suppliers being made in full within the stipulated period of deliver at 173 Bn CRPF Airfeild Dimapur (Nagaland)
13. If the tenders fail to deposit the security money @5 % of the cost of the stores within the time limit of 15 days on acceptance of tender, the EMD will be forfeited.
14. If the suppliers fail to supply the store at 173 Bn CRPF Airfeild Dimapur (Nagaland)) with the stipulated period of 60 days unless extended the security money be forfeited. No extension in delivery period will be entertained without L.D which shall be charges @2% of the value of delayed supplier per month.
15. The tender received after expiry of specified date and time i.e **1100 on 27/01/2023** will not be accepted under any circumstance.
16. The firms should submit / send the tender with proper sealed envelope duly endorsing full address of the firms, tender notice number date of tender due date and time should be written in bold letter on the top of the envelopes.
17. Payment of store in likely to be made within two months from the date of receipt of complete store/ bill.
18. The store will be delivered at 173 Bn CRPF Airfeild Dimapur (Nagaland) . On receipt of Stores in 173 Bn CRPF Airfeild Dimapur (Nagaland)) will be checked / tested by a board of officers detailed by this unit and if any items is fund inferior, the store will be rejected store will have to be taken back by the suppliers at his own cost and risk.
