

MHA vide letter No. II-27012/4/2020/PF.III dated 07th Sept 2020 (copy enclosed) has conveyed the sanction of the competent authority for House Rent Allowance at Belgaum(UA) rates ('Y' class city rates) to the personnel posted at CSJW&T, CRPF located at village Torali, Belgaum (now Belagavi), Karnataka initially for a period of three years w.e.f. 01/07/2020 or till the place 'Torali' continue to fulfill the conditions as laid down in para 3(b)I(iii) of the Ministry of Finance(DOE)'s OM dtd 27/11/1965 as amended/modified from time to time or till issue of any further instructions in this regard by MoF, whichever is earlier.

2. MHA has further advised CRPF to take up a separate proposal on expenditure which has already incurred by CRPF on account of payment of HRA at 'Y' class city rates to the personnel posted at Village Torali, Belgaum, Karnataka alongwith financial implications involved therein.

3. In view of above, copy of subject sanction of MHA is forwarded herewith for further needful action and to submit self contained proposal, duly incorporating all the required/relevant details for regularization of earlier sanctioned HRA to the personnel of CSJW&T, Belgaum.


Subject : **Sanction of House Rent Allowance to the personnel posted at CSJW&T, CRPF, Belgaum renamed as Belagavi, Karnataka**


