**C I R C U L A R**

MHA vide their letter No. I-45023/02/2018-Pers-II dated 14/03/2019 had nominated CRPF as Nodal Force to conduct PST, PET & MST of written qualified candidates of CAPFs(ACs)-Exam-2019 in co-ordination with UPSC. All the events of said examination have been completed and UPSC has declared final result on 05/02/2021. Accordingly, Force allocation of 264 recommended candidates ( Gen-132, OBC-81, SC-30 and ST-21) including 12 ESM for appointment to the post of Asstt. Comdt. (GD) was made by the CRPF and approved by the MHA, allotted to all CAPFs vide this Directorate letter No.A.VI-01/2021-Rectt (AC-2019)-DA-04 dated 05/07/2021.

2. Now, on conclusion of court case pertaining to EWS category, UPSC has released Press Note dated 05/09/2022 vide which result of CAPFs (A/Cs) Exam-2019 has been revised. The break-up of revised result is as under:

3. Accordingly, Force allocation of aforesaid 288 recommended candidates have been recast. There is no change in the earlier Force allocation of 264 candidates made during 2021. As such, Force allocation of remaining 23 EWS candidates, whose result was withheld due to EWS court case, 1 ST against cancellation of candidature of 01 finally recommended Ex-S(ST) candidate and 1 OBC, whose result was withheld due to court case is enclosed at **Appendix "A"**. List of these candidates along with their complete dossiers is being dispatched to concerned CAPFs to which these candidates have been allocated, with the request to issue offer of appointment as per guidelines issued by UPSC.

4.
